

**Sub : Appointment to the post of Chairman, Rail Development Authority (RDA)**

**Qualifications** : The Chairman of RDA shall be a person having proven ability and integrity and should have special knowledge and professional experience of not less than 25 years in either Rail Industry or Finance or Accountancy or Law or Regulatory Affairs.

Candidates who are/have been in Government service should have held a post of Secretary to Government of India or equivalent post in the Central Government/State Government with relevant experience. Application of serving Government servants should be forwarded through proper channel alongwith Vigilance and D&AR clearance.

The candidates should be below sixty two (62) years of age on the closing date of vacancy notice.
