The organizations of Central / State Governments, Districts are eligible to apply for the awards under Innovation category. It may be noted that application under the category does not require prior registration on the Prime Minister's Awards portal and an applicant may apply for any number of initiatives under the category.

3. However, the number of applications received so far is very low. Under the Innovation category, **only 7 applications** have been received so far (list is at Annexure I).



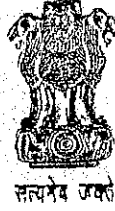

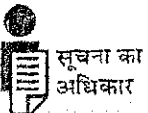
