Sub: Guidelines regarding Demurrage and Wharfage – Power to enhance free time for Alternate Goods shed
Ref: (i) Rates Master Circular/Demurrage-Wharfage-Waiver/2016/0 and amendments thereto
(ii) Rates Circular No.14 of 2020, Board's letters No.TCR/1078/2020/06 dt.20.07.2020 & dt.02.09.2020


Please refer to Board's circulars under reference (i) and (ii) regarding guidelines for Demurrage/Wharfage and Alternate Goods Shed, respectively.

The matter has been examined and it has been decided that to improve the utilization of alternate goods sheds, Zonal Railways (PCCM in consultation with PCOM) may increase the free time for loading/unloading of wagons and/or free time for removal of consignment, upto 50% of the normal free time.

Zonal Railways will send their feedback after six month to assess the impact of the scheme.

These guidelines will be implemented with immediate effect and will remain valid for a period of one year i.e. upto 10.01.2022.

This issues in consultation with Traffic Transportation directorate and with the concurrence of Finance directorate of Ministry of Railways.
