A revised version of the powers of Director General, National Academy of Indian Railways (NAIR) had been issued vide Board's letters referred under (i) above. The matter of delegation of powers to Heads of CTIs (other than NAIR) was under consideration in Board's Office for some time. Now, it has been decided that the powers delegated to DG/NAIR vide letters No.2020/F(X)II/PW/1 dated 23.06.2020 & 14.12.2020 will also be applicable to the Heads of all CTIs. It is also clarified that wherever 'approval of DG/NAIR' is mentioned in the above said letters, the same may be read as 'approval of Heads of CTIs'.

2. These powers may be exercised within the available Budget keeping in view of rules of financial propriety and other restrictions imposed from time to time. Further, prior finance concurrence will be required unless indicated otherwise specifically.


