SUB: Laundry Chemicals for linen washing

A committee of CRSE/C/SR (Convener), CRSE/C/WR, CRSE/SCR and CRSE/C/CR was nominated to identify additional manufacturers of laundry chemicals for linen washing and washing / disinfection of blankets to broaden the list of suitable suppliers. Four firms participated and were shortlisted in the EOI floated by the committee.

Following zonal railways are advised to include, as under, one of the four different brands of laundry chemicals for use in their departmental laundries in future contracts / tenders, along with existing brands being specified, on cost neutrality basis initially for a period of one year. Assessment of efficacy is to be carried out after one year to decide on further continuation / proliferation or otherwise.
