Ref: Railway Board's letter of even number dated 24.04.2023.

To maintain Indian Railways' commitment toward cleaner environment and to comply with various statutory obligations, provision of 1% for environment related works in all works was available. Vide Railway Board's letter No. 2022/E&R/3(2)/1 dated 28.12.2022, D&G charges in various works estimates have been revised including provision for Environment Related Works (ERW). The extant provision for ERW is as under:

"The lumpsum provision of 0.5% for environment related works will be included in estimates chargeable to PH-11,14,15,30 and 42 only and excluding projects funded through EBR-IF."

As per Railway Board's letter of even number dated 24.04.23 (copy enclosed), it was informed that the issue of reduction in provision for Environment Related Works was raised with Finance Dte of Railway Board which inter-alia raised some observations. Thereupon inputs/comments on the observations raised by Finance Dte were requested in the prescribed proforma. The same have not been received so far from Railway.

The scope of Environment Related Works (ERW) covers a wide range of works which help in achieving various environmental goals of Indian Railways. Keeping in view the importance of this fund for environment related activities, it is requested to get the reply expedited so that the case can be processed further in this office.

Vide letter under reference, D&G charges in various works estimates have been revised including provision for Environment Related Works (ERW). Current provision for ERW, as recommended by the committee, is as under:

"The lumpsum provision of 0.5% for environment related works will be included in estimates chargeable to PH-11,14,15,30 and 42 only and excluding projects funded through EBR-IF."

- 2. The above issue of revision in provision for Environment Related Works has been raised with Finance Dte of Railway Board which inter-alia raised following observations:
 - i. The targets/commitments (ERW) given by Railways before various forums may be specified.
 - ii. How much of the specified targets have been achieved after the introduction of 01% Environment charges in the estimates?
 - iii. Quantum of funds accumulated so far under Environment Related Works.
 - iv. Quantum of funds utilized for environment related works.

In view of the above, it is requested to provide comments on above observations of Finance Dte in the attached performa at the earliest so that a suitable justification for reviewing the provision for ERW funds as an integral part of Works Estimates of all Plan Heads (except Computerisation) may be provided to Finance Dte.
