On the occasion of World Environment Day, Hon'ble Prime Minister planted a sapling of peepal tree at Buddha Jayanti Park, New Delhi and launched #एक पेड़ मां के नाम and #Plant4Mother campaign.

As you are aware, our planet is facing unprecedented environmental challenges, including climate change and biodiversity loss. Trees are not just a vital part of our ecosystem but also serve as the lungs of our planet, providing oxygen, absorbing carbon dioxide and supporting biodiversity. It is desired that 60 % of the target may be completed by Sept 2024 to be in sync with MoEFCC targets.
- 4. By joining hands, we can amplify our impact and inspire others to take proactive steps towards a greener future. A drive for tree plantation be launched and should have focus on followings:
 - Plantation drive should be done on mass scale, focus should be on planting on the vacant land under the Railway and also alongside the railway tracks.
 - Ensure survival of planted trees necessary action should be taken like proper watering of plants and timely checkup may be conducted.

- Raise awareness among the railway personnel and passenger that plantation could mitigate climate change and should be encouraged through IEC programmes to participate in #Plant4Mother campaign.
- 5. Together, we can make a significant difference and leave a lasting legacy for future generations. Your insights and expertise will be invaluable in ensuring the success of "#एक पेड मां के नाम". I look forward to your positive response and to embark on this journey towards a sustainable tomorrow.
