- 1. Amendment 01/2022 to Model SOP 2018 was issued vide letter under reference-1 in which item 37/A.l of Works matter regarding Sanction of proposals for 'Outcome & Activity' based outsourcing of items was amended. In the remarks column it is mentioned that "Cases requiring exemption from 'Outcome & Activity' based Outsourcing would require personal approval of the GM with specific reasons to be recorded in writing."
- 2. Now in the para-3 of letter under reference-2, it has been mentioned that "station cleaning and colony cleaning contracts will continue to be covered under the existing instructions of outcome basis contracts."
