Sub: Green Certification of Railway Stations and other Railway Establishments.

CME (IT & Safety)/Western Railway, vide letter dated 27.11.2024 has sought clarification as to whether Green Rating for different types of Railway Establishments (Railway Office buildings, Industrial Units, Major Railway Stations, Major Hospitals, Railway Schools and Training Centres) is to be obtained from CII only or any other eligible National/International certifying body.

- 2. Also, Central Railway vide letter under reference (i), has informed that the tendering process for green certification of 136 more stations (02 station per division from NSG 1-4 category), which were assigned to CR vide Railway Board's letter under reference (iv), couldn't be materialized and proposed that the work of Green Certification of Railway Stations may be decentralized.
- 3. The issues raised by both the Railways have been examined and following is advised:
  - (i) Green Certification of railway establishments may be obtained from eligible certification body through competitive bidding as originally indicated vide Railway Board's letter dated 28.06.2022 (ref. iv), except for the stations earmarked as per directions of RB given vide letter dt. 12.03.2020 (ref. iii).
  - (ii) Individual Zonal Railways may process for green certifications of these stations under their jurisdiction at Zonal Railway level itself.

Reference above Indian Railways planned to scale up Green Certification of stations, and accordingly 136 more stations (02 NSG 1-4 stations from each division) beside earlier 68 stations were to be taken up by each Railway for Green Certification on competitive bidding basis at maximum estimated cost of 6 lakhs per station. Central Railway was nominated as nodal Railway for floating/finalizing the tender for green certification of stations through competitive bidding in coordination with other Zonal Railways.

Accordingly, the subject tender was floated on IREPS on 21/08/2024 with required approval and sanction of competent authority & opened on 20/09/2024. As per Techno-commercial Tabulation statement, only 01 offer (Through e-tender) was received at the time of opening on the scheduled date. However, the participating firm failed to meet the stipulated Technical Eligibility Criteria outlined in the Tender Document; hence, the subject tender was discharged.

Considering feeble response and non-compliance of eligibility criteria it is proposed that work of Green Certification of Railway Stations may be decentralised and Zonal Railways be directed to process certification in their zones itself.



Sub: Green Certification of Railway Stations by CII

Indian Railways have signed an MoU with CII for promoting facilitation of green initiatives in Indian Railways and Stations on 13.9.2019 for a period of 3 years. So far 13 railway stations have been certified green and these stations have reported substantial annual savings besides other intangible benefits like improved station facility management, daylight & ventilation and thermal comfort for occupants, effective waste management, improved pedestrian and vehicular access to station & low carbon mobility options, user-friendly design for differently abled, use of green products for construction & renovation. The various aspects of green certification of stations include sustainable station facility, health, hygiene & sanitation, water & energy efficiency and smart & green initiative.

Railway Board has approved a proposal for green certification of one major station (out of NSG 1-4) per Division of each Zonal Railway at a maximum cost of ₹6 lakh per station. Cll will depute a technical staff at each zone for liasoning and follow up and will also hold a capacity building program (on chargeable basis-per zone -₹ 75,000) as well as develop an exclusive app for green railway station and online tool for submission of documents and review. They will also provide additional support for implementation by organizing a meet on green products and technology suppliers for cross fertilization of ideas. These are exclusive of GST which is payable as per rates applicable.

Sub: Policy initiative for seeking Green Ratings of IR Establishments.

A number of programmes and policies have been launched in the recent years to establish Indian Railways as an Organisation sensitive towards Environment, and to reinforce IRs image as a "Green Transporter". In continuation, it is now decided to issue "Policy instructions" for undertaking Green Rating Certification for different types of Railway establishments. The certification would mainly cover the assessment of parameters having direct relations to environment improvement, such as, Energy conservation measures, Use of renewables, Water recycling / rain water harvesting, Waste management (Solid & Liquids) and its disposal, Tree Plantation / Green cover, etc.

Under the proposed policy, following are to be covered:-

- (A) Green Rating certification & Energy Star Rating for Railway office buildings.
- (B) Green Rating for Industrial units (PUs and Workshops).
- (C) Green Rating system for major railway stations
- (D) Green & Energy star Rating for major hospitals.
- (E) Green Rating for Railway Schools & Training Centres

The above certification would not only provide for a substantial savings in energy, fuel and water and other benefits of environment conservation, apart from establishing image of IR as a "Green Organisation".

You may arrange to give appropriate directions to the concerned officials to initiate process of certification from any of the Recognised Certification Body. EnHM, Dte. in the Railway Board has been instructed to provide guidance, if required, on issue of certification. Your action plan on the above initiative may be forwarded to Board by 28.02.2017
