Sub: Swachh Train Prayas

Focused attention on enhancing cleanliness standards in trains in a targeted manner needs to be given further emphasis. For this purpose, besides other actions, following is planned:

- i. Based on recent feedbacks, 2 trains of each division have been shortlisted and mapped origin-destination and route-wise for inspections at origin, destination and 2-3 enroute stations. List of trains including enroute inspecting stations is provided in the following google sheet:

- ii. A Google drive has been created for each Zone, Division and shortlisted train(s) within the respective folders.

SrDME/Co-ord of the divisions is requested to locate their trains in the Google drive referred above and arrange immediate suitable action by all concerned.

- iii. The trains indicated therein need to be inspected by the concerned SrCDOs/CDOs at the originating station and destination station respectively.
- iv. The said trains are required to be further physically checked/monitored/observed, to the maximum extent feasible, by SrDMEs concerned at designated enroute points, for coach cleanliness (with special emphasis on toilets) and condition of bio-tanks.

- v. Post-inspection, pictures(geo-tagged and date/time stamped) of the following areas of the train (coaches) need to be uploaded in the correct folder on the Google drive. Besides any other pictures, following need to be necessarily provided:
 - a. Lavatory corners, along with the condition of the toilet pan
 - b. Dustbin in gallery area
 - c. Bio-tanks ininspected coaches
- 2. General guidelines for saving time and effort in analysis of actions taken:
 - a. Inspecting officer(s) must merge all pictures, in a meaningful manner, into a single PDF and then upload the said PDF file to the correct folder in the Google Drive.
 - b. If any specific points need to be highlighted, same may be mentioned in a document provided therein(which should thereafter be updated in a continuous manner).
- 3. Further, inspection done by nominated officers from Railway Board need to be uploaded in a separate folder on the Drive.
- 4. All concerned may kindly ensure implementation, without fail. Railways may add any other actions for Swachh train prayas, other than above, as deemed fit.
- 5. Presently, the exercise has to be carried out for 15 days, starting w.e.f. 27.04.2025. Presentations on the actions and outcomes thereafter will need to be made by the CRSE/Chg of the respective Zonal Railways.
