Action Plan for the Ministry of Railways: World Environment Day - 2025

Theme: End Plastic Pollution

Objective: To raise awareness and active participation in initiatives aimed at reducing plastic pollution.

<u>Timeline</u>: 22nd May 2025 (kick off)-05th June 2025 (culmination)

Target Audience: Railway staff, Commuters, general public and other stakeholders.

Activities and Initiatives

22nd May-24th May, 2025: Launch and awareness compaigns.

- Event launch with awareness campaign.
- Assessment/Disposal/Monitoring of Plastic Waste.
- Initiate a social media campaign on one's contribution towards ending plastic pollution.
- Use of posters, pamphlets, and digital materials across stations to promote environmental awareness for using of steel/recyclable plastic lunchboxes & bottles and towards prohibition of Single Use Plastic.
- Organize workshops for railway employees, focusing on the importance of reducing plastic usage, recycling practices and waste management.
- Public awareness drives at railway stations to encourage travelers to "Carry Your Own Water Bottle".

25th May 2025 - 27th May 2025: Cleanliness Drive

- Ensure waste segregation bins on platforms. Create awareness campaigns for passengers to use them.
- Conduct cleanliness drives in railway stations and surrounding areas. Engage local communities and NGOs.
- Promote Non-Plastic Eco-friendly Cutlery: IRCTC to launch drive for using biodegradable or non-plastic cutlery.
- Install additional waste segregation bins on platforms. Create awareness campaigns for passengers to use them.
- Sensitize railway staff on proper waste segregation practices, especially focusing on organic waste and reduction of plastic usage.

(28th May 2025 to 30th May 2025): Reduce Plastic Pollution

- Review of maintenance/working of Plastic Bottle Cushing Machines.
- Special drive for monitoring vendor stalls at Railway Stations regarding implementation of ban on Single use plastic....
- Inspection of water refill points at railway stations. To encourage passengers to refill their own bottles, reducing single-use plastic bottles.
- PA system for use of own water bottles and creating awareness regarding plastic pollution.
- Cooperation of passengers be sought for limited use of plastic bottles and other items through PA system on the Railway Stations. Feedback in this regard may also be taken from passengers.
- Train Service Providers: Encourage suppliers to replace virgin plastic products with recycled alternatives in catering and other services.
- Organize Nukkad Nataks with the help of NGOs &other interested parties and arrange interactive sessions with school children about plastic pollution and the ways to curb the menace.
- Vendors/staff be sensitized about partial cutting of packaging bags (milk & other dairy items) so as to reduce microplastic pollution.
- Continuation of the cleanliness drives.

31st June 2025 - 2th June 2025 Sustainable Railway Operations

- Special drive to maintain parks around stations.
- Proper maintenance of greenery and parks/gardens in Railway colonies.
- Awareness campaigns in Colonies
- Nukkad natak to be organized in colonies
- Community engagement for organizing clean-up drives in colonies, around railway stations, tracks and nearby areas.
- Training on sustainable practices. Monitoring and strengthening waste management practices & bio-toilets inspection.
- Eco-friendly products like bamboo toothbrushes and neem combs may be promoted for sale under One Station One Product scheme.
- Drawing, essay, quiz competitions on sustainable environment.
- Encourage use of cloth/jute bags at stations.
- Promote digital & paperless ticketing.

3th June 2025 = 4th June 2025: Passenger Involvement and Water Conservation.

- Rainwater harvesting, water recycling initiatives.
- Clean and revive water bodies near railway premises.
- Organize Nukkad Nataks with the help of NGOs and arrange interactive sessions with school children about plastic and water pollution and ways to curb it.
- ACWPs water recycling systems should be inspected for proper working.
- Water recycling needs to be ensured in production units and other railway establishments wherever possible.
- PA system for use of own water bottles and creating awareness regarding plastic and water pollution and conservation measures.

5th June 2025 (World Environment Day; Culmination)

- Observation of World Environment Day in an appropriate and befitting manner keeping in focus this year's theme of ending Plastic Pollution.
- Publicity/display of achievement and events carried out.
- Campaigns involving scouts/NCC, social groups and public influencers/dignitaries on environmental awareness be organized at major Railway Stations, workplaces and colonies and in local areas, wherever possible, to educate the passengers/masses.
- Culmination event to celebrate achievements, recognize contributors, and release of summary report of the seven-week celebrations.
- Suitable awards/recognition may be given to best performing stations/divisions/individuals etc by Divisional/HQ level.
