Sub: Delegation of Power to Railway Board Officers.


Ref: MSOP-2018 issued vide Board's letter No. 2018/Trans./01/Policy dated 24.07.2018.

Delegation of powers to Railway Board Officials has been under consideration of the Board for quite some time.

Board (FC& CRB) have delegated following powers to Additional Members and Principal Executive Directors of Railway Board.

- (i) Additional Members (AMs)/Principal Executive Directors (PEDs) will exercise analogous powers as applicable to GMs/PHODs (as provided in the Model SOP-2018) to the extent required to be exercised by AM/PEDs at Railway Board level in consultation with Associate Finance.
- (ii) Addl. Members/Principal Executive Directors (Independent Charge) will exercise powers to enter into consultancy contract for a value upto ₹ 5 crore (each case) with 3 Member SAG level Tender Committee, nominated by the AM/PED (Independent Charge). One Member of the SAG level Tender Committee should be from Finance.
- (iii) Additional Members/PEDs (Independent Charge) can maintain a cash imprest of ₹ 50,000 for meeting any contingent expenditure considered essential for smooth functioning of the Directorate, following extant instructions in respect of the imprest. Accountal of the expenditure may be kept at the level of a Deputy Director/Joint Director/ Director.
- (iv) AMs/PEDs will also have the powers to sanction "Award" during their field visit upto a limit of ₹ 50,000 per occasion (Group Award) subject to an individual staff/officers not getting more than ₹ 5000 per occasion, subject to an annual ceiling of ₹ 3 lakhs per AM/PED.


