The matter of hiring of Data Entry Operators against vacancy in CTIs, has been examined in Board's Office and it has been decided by Board(MF & CRB&CEO) to delegate the powers to Heads of CTIs by inserting a new item in Board's letter dated 23.06.2020 [under reference (i)] as indicated below:

New Item	Description/ Nature of Power	Extent of Powers
26-A	Hiring of Data Entry Operators against vacancy.	Head of CTIs can hire Data Entry Operators through agency maximum of 2 (two) or 50% of the existing vacancy, whichever is less, on the contractual basis through GeM on need/justification subject to availability of funds and following due process of estimation, tendering (GeM) and approvals with Finance concurrence.
		Note: Continuation of this arrangement beyond three years (i.e beyond May 2027) would be reviewed by Railway Board.
