With reference to DG/NAIR's letter under reference (1) above, Board (MS, FC & CRB) have approved the following:


1. Delegation of power to DG/NAIR regarding conducting training courses with IITs/IIMs/NITs on nomination basis/single source basis within the power of sanction with concurrence of associate finance, subject to full justification for single source selection on file and reasonableness of rates.

The same is also approved for ISB, Hyderabad and IISc, Bangalore on similar basis as these Institutes are Institutes of repute internationally.

2. DG/NAIR shall consider selecting IITs/IIMs/NITs/IISc, Bangalore/ISB, Hyderabad based on the availability of the Course/Faculty/Infrastructure/Fees by taking their offers for a particular course.
3. The training courses shall be conducted within the overall limit of the available funds.
4. DG/NAIR shall frame rules and guidelines in consultation with associate finance for process and selection of the Institute.
