Sub: Delegation of powers to permit Air Travel in connection with the officers posted on USBRL Project.

Ref: Northern Railway's letter No.98-G/Model SOP/RB/Corrs/2018 dt. 30.07.2018.

In terms of Board's letter No. F(X)II/2015/PW/7, dt. 12.06.2017 followed by letter No. 2017/Trans/01/Policy, dated 18.10.2017, powers had been delegated to GM to permit Air Travel on duty to officers not below Junior Scale level subject to certain terms and conditions.

Further, in terms of Board's letter of even number dated 09.11.2016 and letter No.2017/Trans/01/Policy, dated 09.01.2018, certain delegations of powers w.r.t. sanction of Air Travel have been made in connection with USBRL Project.

Now, Northern Railway's above referred proposal regarding delegation of powers to permit Air Travel in connection with Udhampur-Srinagar-Baramulla Rail Link (USBRL) Project has been examined in Board's office and it has been decided with the approval of Board (FC) that:

- (i) The power to permit Air Travel on duty on Delhi-Jammu-Srinagar-Delhi circuit, for officers of all Grades (JS, SS, JA & SAG and above) posted in USBRL project may now be delegated to CAO/C/USBRL for officers under his administrative control as a special case for a period upto 30.09.2019.
- (ii) This will be subject to the ceiling limit of allotted budget for Air Travel.
- (iii) This will also be subject to the other Terms & Conditions/instructions issued from time to time by Board's office on 'Air Travel'.
