Sub: Delegation of Power to NAIR/CTIs and CTIs' Co-ordination Cell at NAIR.

With reference to DG/NAIR's letter at (1) (2) and (3) and Railway Board's letter at (4) above, Board (MS, FC & CRB) have approved the following:

1. Permission for Air Travel Facility to Eminent Visiting Faculty:

1.1 The annual ceiling limit of the total expenditure with regard to permission for air travel to Eminent Visiting Faculty by DG/NAIR is enhanced to Rs 7.5 Lakh per annum.

1.2 All other extant terms & conditions on the above subject, as issued vide **Board's letter No. F(X)II/2009/PW/10 dated 09.04.18** (item No 3.viii.B.i) shall remain unchanged, and as modified from time to time.

2. To Incur Expenditure towards Presenting Mementos to Visiting Faculty and Faculty on Transfer:

2.1 Full powers with an annual ceiling limit of Rs 2 lakh to DG/NAIR. Finance Concurrence is not required.

2.2 Other conditions, if any, in respect of powers to incur expenditure towards presenting mementos to Visiting Faculty and Faculty on transfer will remain.

3. Hiring/Engaging Sports Trainers at NAIR & CTIs:

DG/NAIR & Director/CTIs are permitted to tie-up with staff from Sports Quota to impart training to Trainee Officers in the existing facilities. The rate may be decided by the Head of the CTIs in consultation with associate finance within the overall budget allotment for the concerned CTIs/NAIR.

4. Centralised Training Institutes (CTIs) Co-ordination Cell:

4.1 A CTIs Co-ordination Cell may be set up at NAIR under DG/NAIR for effective coordination with CTIs, Railway Board, and other organizations.
