Sub: Revision of Training Fee for Foreign Nationals over IR Establishments under Government of India (GoI) sponsored Programmes.

With reference to Director/Technical/RITES's letter at (1) and Board's letter at (2) above, regarding training fee charged for Foreign Nationals in Railway Training Institutes under Government of India sponsored programmes, Board (MS, FC & CRB), have approved the following:

1. The Fee to be charged for Government of India (GoI) sponsored programmes organized through Ministry of External Affairs (MEA) like Indian Technical and Economic Cooperation Program (ITEC)/Special Commonwealth African Assistance Program (SCAAP) for training to foreign nationals shall be, as approved by MEA. The Railway Training Institutes and CTIs, directly or through any Railway PSU may organize the training course. The entire amount as paid by MEA shall be charged by the Railway Training Institutes & CTIs.
2. The Fee to be charged for GoI sponsored training programmes other than those in Para 1 above, for foreign nationals where fee is met out of GoI funds shall be decided by DG/NAIR in consultation with associate finance for the CTIs. The training course may be organized directly or through any Railway PSU.
3. The Fee to be charged for the training programmes, other than covered in Para 1 & 2 above, for foreign nationals, the existing rates as circulated vide Railway Board's letter no. E(TRG)2008(22)/1-A dated 08.11.2016 or as modified from time to time shall continue.
