**Sub: Correction Slip No 6 to Model SOP issued vide letter no 2017/Trans/01/Policy dated 26.10.2017 - regarding ex gratia payment - RPSF**

In Railway Board Model SOP (issued vide Railway Board letter No 2017/Trans/01/Policy dated 26.10.2017), Part F, "Establishment Matters", Non Gazetted, item no 63, DRMs have been given Full Powers to sanction ex-gratia payment to the dependents of railway employees who die in performance of their bonafide official duties.

In addition to the above empowerment, Board (MS, FC & CRB) has approved that **"PCSC/RPSF is given Full Powers to sanction ex-gratia payment to the dependents of RPSF employees who die in performance of their bonafide official duties, with the concurrence of the associate finance of the bill paying unit of the RPSF employee"**.


