With the Approval of Railway Board (ME, FC & CRB), following changes are made in Board's instructions referred above.

1. The value Rs 100 Crore mentioned in row 5 of table in letter under reference 3 above may be replaced with Rs 300 Crore. With this change, the powers of acceptance of Works Tender (for Each Tender) and the accepting authority are as under:

| Sl | Powers of Acceptance of Works Tender (for each tender) | Accepting Authority |
|----|--|--|
| 1 | Upto Rs 50 Lakh | Selection grade/JA Grade/Sr. Scale holding independent charge, subject to stipulations mentioned in letter under reference 2 |
| 2 | Upto Rs 4 Crore | Selection grade/JA Grade |
| 3 | Above Rs 4 Crore and upto Rs 20 Crore | SAG/DRM/ADRM/CWM |
| 4 | Above Rs 20 Crore and upto Rs 75 Crore | CHOD in SA Grade |
| 5 | Above Rs 20 Crore and upto Rs 300 Crore | AGM / PHOD in HAG |
| 6 | Above Rs 20 Crore and upto Rs 300 Crore | CAO/RE in HAG |
| 7 | Above Rs 20 Crore and upto Rs 500 Crore | CAO/Construction in HAG |
| 8 | Full Powers | General Manager |

Note: (i) Where no AGM is posted, such tenders shall also be accepted by GM.
(ii) The Tender Committee for Tenders to be accepted by 'CHOD in SA Grade' shall be of SA Grade level

2. Para 2 of letter under reference 4 above is revised as:

"However, for all works contract tenders within the Tender Acceptance Powers powers of SAG/DRM/ADRM/CWM valuing more than Rs 10 Crore, 'Two packet System shall mandatorily be followed, except in cases where it is decided by an executive not below SAG level for reasons to be recorded in writing and with

the concurrence of **associate Finance**, that it would be advantageous to follow 'Single packet system". For Tenders valuing beyond the tender acceptance powers of SAG/DRM/ADRM/CWM, and costing more than Rs 10 Crore, decision of executive not below HAG in consultation with FA& CAO shall be required to adopt Single packet system of tendering in case of works tenders"


