Sub: Sanction for Structure Gauge infringement (As per fig. DMWSG-2 of SoD) (Vertical Clearance) Condonation to Schedule of Dimensions (SOD) at Chainage 66019.448 meter and Chainage 66022.448 meter of Line 7 Extn. (Mukundpur to Maujpur) with Portal of Depot line 8 extn. (Entry-Exit)

With reference to DMRC letter dated 29.05.2025 (ref. ii above), sent through Chief Commissioner of Railway Safety (CCRS), New Delhi vide letter dated 02.06.2025 (ref. i above), the sanction of Ministry of Railways is hereby communicated for Condonation of Structure Gauge infringement to Schedule of Dimensions (SOD) at Chainage 66019.448 meter and Chainage 66022.448 meter of Line 7 Extn. (Mukundpur to Maujpur) with Portal of Depot line of line 8 extn. (Entry-Exit) for both UP & DN Line as detailed below:

- i. 306 mm in Vertical clearance above Rail Level reducing to 299mm (As per fig. DMWSG-2 of SoD) from chainage 66019.448 m to 66022.448 m in DN Line
- ii. 296 mm in Vertical clearance above Rail Level reducing to 289 mm (As per fig. DMWSG-2 of SoD) from chainage 66019.448 m to 66022.448 m in UP Line

The above condonation is subject to stipulation as under:-

- 1) Clearance shall be jointly measured every 06 months by engineering Operating, TRD and S&T Official and recorded.
- 2) SoD infringement details shall be maintained in a SoD infringement register. To be maintained by TRD department
- 3) All the specials instruction and stipulations of condonation of SoD infringement shall be mentioned in station yard ESP, SIP SWR and SWRD.
- 4) OHE safety screen shall be provided in full crossing span of Line-7. During planned/ routine maintenance of DMRC Line-7 OHE, due care shall be taken by DMRC to ensure the vertical clearance from Rail level to soffit of Line-8 Depot line portal never reduces below the condoned clearances as given in (i) and (ii) above.

5) Electrical Clearance from charge portion of OCS and pantograph Kinematic envelope to structures/ nearby infringements should be maintained to minimum 584 mm for DN line and 587 mm for UP line. It should be ensured by CEIG/EIG and TRD officials.

6) No attachment/ board etc should be fixed on infringing structure over the infringement location.
