**Sub: Sanction to run and operate 4-wheeler, Broad Gauge (BG) Centenary Maintenance Vehicle (Tower Wagon) supplied by M/s. Phooltas, Patna to M/s Phooltas's Layout Drawing No. OHE - 4B1-00 01.00 Rev. 0 for Delhi Metro Broad Gauge Network.**

In reference to the letter cited above, provisional sanction of Ministry of Railways is hereby communicated for operation of 4-wheeler, Broad Gauge (BG) Centenary Maintenance Vehicle (Tower Wagon) supplied by M/s. Phooltas, Patna to M/s Phooltas's Layout Drawing No. OHE-4B1-00 01.00 Rev. 0 **up to a maximum speed of 25 (TWENTY FIVE) kmph** over Delhi Metro Rail Corporation Limited (DMRC)'s Broad Gauge Network. The sanction is further subject to the following conditions/stipulations:

- (i) Observance of all permanent and temporary speed restrictions already in force and/ or those that may be imposed from time to time on various accounts.
- (ii) Observance of all conditions laid down in RDSO's Provisional Speed Certificate No. UTHS/66/DMRC dated 14.08.2015 and DMRC Joint Safety Certificate No. DMRC/Elect./ED/TR/T-52 E/TW/DMRC/JSC dated 28.08.2018 and concomitant Track and Bridge Certificates.
- (iii) It should generally work in non-revenue hours. In exceptional circumstances, it can be used during revenue hours when it is working within the limits of Engineer's possession after ensuring that all the passenger trains in the vicinity are well protected.
- (iv) In case of failure of rolling stock in the section, it should be cleared from the section with the help of another rolling stock capable of working in ATP mode. CMV shall not be used for clearing of the section.

- (v) Periodical maintenance schedules shall be strictly followed.
