SUB: Procedure for booking of special trains/coaches by IRCTC on behalf of Ministry of Home Affairs for movement of Paramilitary forces during Assembly Election in Himachal Pradesh in November, 2017 and in other states in future.


REF: This office letters of even no dated 11.03.2014, 08.03.2016 and 30.12.2016.

Further to the above referred letters dated 11-03-2014, 08.03.2016 and 30.12.2016, it is advised that Zonal Railway shall follow the same procedure as prescribed in the above referred letters for booking of special trains/coaches by IRCTC on behalf of Ministry of Home Affairs for movement of Paramilitary forces during Assembly Election in the State of Himachal Pradesh in November, 2017 and also for booking of special trains/coaches by IRCTC on behalf of Ministry of Home Affairs for movement of Paramilitary forces in future for election purpose. However, service charge @ 30% included in the FTR fare shall be retained by Railways. IRCTC shall pay FTR fare plus GST as applicable on FTR fare in respect of movement of para military forces by AC Coaches. For other than AC Coaches or First Class, no GST shall be levied.


2. In addition, Ministry of Home Affairs shall pay facilitation charge @ 5% on FTR fare plus applicable GST to IRCTC for the various services rendered by IRCTC in this regard namely, the advance payment given by IRCTC to Railways, co-ordination work with Railways, investment of manpower for booking of trains, arrangement of catering charges, billing for re-imburement, refund from Railways etc.

3. This issues with the concurrence of the Finance Commercial & Accounts Directorates of Ministry of Railways.

4. Necessary instructions may be issued to all concerned immediately.


