Sub: Instructions with financial implications issued to Railways without finance concurrence.


It has been brought to the notice of Board's office that some of the technical directorates have been issuing the instructions having financial implications without concurrence of associate finance.



Attention is invited to Board's letter of even number dated 17-12-1997 wherein the Railways were advised not to act upon any instructions having financial implications unless issued with the specific concurrence/ approval of the Ministry of Railways. One of the Railways has raised a doubt as to whether concurrence/ approval of Finance Directorate of Ministry of Railways is to be insisted upon only in those cases which have a bearing on economy in expenditure or whether this should encompass all instructions having financial implications.

It is clarified that the said instructions are applicable in all cases having financial implications.


