GST Matter GST Circular No 9 RBA No. 58/2017

No. 2017/AC-II/1/6

New Delhi, the 18th May, 2017

General Managers, All Zonal Railways and Production Units

Sub:- GST-Registration.

Kindly refer to Board's letter of even No. dated 11th May, 2017 addressed to all Production Units and Board's letter of even No. dated 12th May, 2017 addressed to all the Zonal Railways. In continuation to these instructions, following directives are issued relating to Registration of Indian Railways in GST.

1. GST Registration

It has been decided by Board that Ministry of Railways will get a single registration in each State/UTs. The nominated Railway will be designated as the 'Principal place of Business' for GST purpose for that particular State/UT, without any Zonal/Divisional demarcation. This would imply that inter-zonal or Divisional supplies within the same State/UT would not attract any GST. The registration of the Production Units in State/UTs will not be taken separately as a business vertical. In such a situation, the Production Units would be subsumed in the registration taken for Zonal Railways. Keeping this in view, a list of Principal Place of business as approved by Board is placed as Annex-A. All the nominated GMs may kindly get the GST registration done in their respective areas, in the name of 'Ministry of Railways', in the capacity of 'Principal Officer' for GST purposes in the assigned State/UT.

2. Role of nominated GMs in the Principal Place of Business

As a Principal Officer of the State/UT, the nominated GMs are responsible for compliances under the GST law, which is brought out as under:-

- Taking registration under GST regime
- Payment of output tax liability for IR's outward supplies made in the State / UT
- Taking input tax credit for the entire State / UT (registration wise) for set-off against output tax liability for the entire State / UT
- Filing of monthly / periodical / annual returns
- Maintenance of accounts and records at Principal and Additional places business in the State/UT (Necessary utility will be developed by CRIS for this purpose)

Railway Board vide RBA No. 3/2017 dated 20th January, 2017 had desired that Consultants should be in place in each of the Zonal Railways and Production Units for this activity.

3. Income Tax-PAN

Action is being taken to obtain Income Tax Permanent Account Number (ITPAN) in the name of Ministry of Railways. As soon as we get the ITPAN, same will be communicated to all the Principal Officer of each States, to enable them to apply for GST Registration.

- 4. To facilitate filing of GST Returns, other GST Compliances, Accounting policies of IR relating to GST, necessary orders are being issued separately.
- 5. It is possible that some of the Railways/Production Units may have migrated to the GST regime on the authority of their existing VAT/Excise Duty/Service Tax registrations. It is mentioned that the same needs to be surrendered forthwith, in the light of above Single Registration of Ministry of Railways in each State/UTs.
