Sub: Review of the sanctioned 2nd Revised Estimate of the work of “ERP based Human Resource Management System (HRMS)”.

Ref: Railway Board’s letter of even number dated 10.03.2025.

Sanction of the 2nd Revised Estimate of the work of “**ERP based Human Resource Management System (HRMS)**” at a cost of Rs.186.86 crore was communicated vide Board’s letter referred above.

Subsequent to above, request for review of the 2nd Revised Estimate was received and has been agreed to by the competent authority in Board for including the following items at a total cost of Rs.72,96,71,520/- (Rupees seventy two crore, ninety six lakh, seventy one thousand five hundred and twenty only) :

Thus, with the addition of above items amounting to Rs.72.96 crore, the cost of the 2nd Revised Estimate has been revised from Rs.186.86 Crore to Rs.259.82 Crore (Rupees two hundred fifty nine crore and eighty two lakh only, subject to following conditions:

- (i) Procurement of PC is to be done for only those officials engaged in HRMS work, who either do not have a PC or the PC available with them is not in working condition.
- (ii) Procurement should be need based. Before actual procurement, the requirement should be sent to the Pay Commission Directorate (Nodal Directorate for this work) to check and submit to C&IS Directorate of Board’s office.

- (iii) There should be no overlapping in the procurement of items under this work and the general department specific procurements.
- (iv) All the staff and officials who will be getting the PCs under this project, will not be included in the allotment of PCs in the other procurements.

This issues with the concurrence of Finance Directorate of Ministry of Railways.
