DFCCIL vide letter under reference (vi) has informed that the work between Son Nagar - Andal Section (375 Km) of Son Nagar - Dankuni Project (538 km) has been sanctioned as multi tracking project and DFC alignment no more passes in this stretch.

2. 14 ROB's were sanctioned on cost sharing basis with DFCCIL on this section for which DFCCIL will not be sharing any cost now. The execution of these 14 ROB's and 4 other sanctioned ROB's was earlier entrusted to DFCCIL. They have now requested transfer of execution work of all 18 ROB's (incl. 14 ROB's which are now to be done with 1.00 % railway cost) to ECR.

The same has been considered and it has been decided that the execution of these 18 ROB's shall now be done by ECR.


3. Zonal railways are further advised to plan the execution of other ROB/ RUBs as per approved DPR & inform if any assistance is required.

As stated vide DFCCIL letter dated 11.03.2022, Sonnagar-Gomoh section of EDFC is to be developed on PPP mode and elimination of LCs is necessary for providing encumbrance free land avoiding physical obstruction due to construction of ROBs/RUBs during execution of the PPP project by the Concessionaire to fulfil the obligations of DFCCIL. Early elimination of LCs is essential for successful execution of Sonnagar-Gomoh section of EDFC on PPP mode.

Due to feasibility issues, additional 13 RUBs on this route have been converted into ROBs which are sanctioned under umbrella provision for 2022-23 and individual works have to be sanctioned now. DFCCIL has also to sanction their share of cost for these ROB works.

Out of earlier sanctioned 8 ROBs, one works each is being done by NHAI and BSRDC. On 2 more ROBs, ECR has already started civil works. On remaining 4 ROBs, no civil work has been started by ECR.

Considering the increased scope of work of 13 ROBs, it is decided to assign 13 new ROBs and 4 earlier sanctioned ROBs (where no civil work has been started by ECR so far) for execution to DFCCIL.

All balance 31 RUBs that have already been assigned to ECR for execution, may continue to be executed by ECR. However, sanction for DFCCIL share for these RUBs shall be obtained by DFCCIL.

Both ECR and DFCCIL are directed to execute works related to commissioning of ROBs/RUBs that have been assigned to them.

Initially there were 14 locations in between Sonmagar - Gomoh on EDFC route, where
LHS were sanctioned but later these were found technically not feasible. (List is
attached as Annexure - A). Out of these 01 location at LC no. 37/B/T was on detoured
alignment of DFC.


Later on, ECR/Con informed that construction of 02 LHS within these 14 locations (at
LC no. 6C & 18C) are feasible but construction of 03 additional sanctioned LHS (at LC
no. 7C, 8C & 17) are technically not feasible.

Hence in light of above, a total of 15 nos. of LHS which were technically not feasible
were proposed for ROB and got sanctioned in FY 2022-23. List of these 15 sanctioned
ROBs is attached at Annexure - B.

Based on RB's letter under reference (i) above, DFCCIL/KKK was assigned the work of
these 14 new sanctioned ROB's as well as 04 earlier sanctioned ROB's. List of these 18
ROBs is attached as Annexure - C. DFCCIL agreed for cost sharing of these new
sanctioned ROB's vide their letter reference (ii) above, (copy attached)

Now vide ref (iii), DFCCIL/KKK has intimated that their consent of cost sharing for
construction of 14 ROB's between Sonmagar - Gomoh section of DFC route is hereby
withdrawn, because construction of Sonmagar - Andal (374.53 route km) project has
been sanctioned as multi tracking project and work to be executed by ECR & ER.

This letter should be read in suppression of this office earlier letter issued vide
reference (iv) above.



In this stretch, work of elimination of 18 level crossing gates by ROB was earlier entrusted to DFCCIL for execution by Railway Board vide letter No. 2015/CE-IV/ROB/DFCCIL (Pt-1) dated 25.04.2022.

As the work between Sonnagar and Andal stations has now been sanctioned as multi tracking and DFC alignment no more passes in this stretch, it is requested that execution of these 18 ROB works may now be entrusted to ECR.
