Board has issued instructions from time to time on GCC and EPC documents with the approval of Board (Member Infrastructure) along with the concurrence of Finance Directorate of Railway Board.

- 2. References are regularly received in Railway Board from Zonal Railways/PUs etc. for clarifications as well as suggestions for changes/amendments in the existing instructions from the level of Chief Engineer without approval of General Manager. Some references/complaints have also been received in the Board's office directly from the contractors.
- 3. In view of the above, Zonal Railways are hereby advised as under:
  - a. Such references should be sent only by the PHODs/CAOs(C) along with the opinion of Associate Finance with the approval of General Manager.
  - b. To resolve the issue between stakeholders of contract agreement, all concerned officers of Zonal Railways/Divisions/PUs are advised to meet with stakeholders on regular basis. The pending issues/references if any related to any Railway Board's policy shall be sent to the Board's office by the PHODs/CAOs(C) along with the opinion of Associate Finance with the approval of General Manager for necessary deliberations.


Instructions have been issued from time to time by Railway Board regarding empowerment of field organizations of Indian Railways for better contract management and speedy implementation of projects/works.
