

Sub: Proposal for "Yard improvement and up-gradation over Indian Railway".

1. Umbrella work of "Yard improvement and up-gradation over IR" has been sanctioned in PH-31 in WP 2024-25. Sub-umbrellas for zonal railways have also been distributed vide letter under Ref (i). Consequently, vide letter under Ref (ii) zonal railways were asked to propose itemized works and send the same to Board for shortlisting in a prescribed proforma.
2. Maintenance standards have been issued for 'Passenger Running Loop Lines' and 'Goods Running Loop Lines the derailments on which may affect the traffic movement on main lines or passenger loop lines' vide letter under Ref (iii) & (iv) respectively.
3. Targets to achieve the above standards in all yards have been set in a time frame of 12 months for Passenger Running Loop Lines and 30 months for said Goods Running Loop Lines.
4. Zonal Railways are advised to prioritize yard works in such a manner that stipulated maintenance standards are achieved in all the yards within targets indicated above in the cost of sub-umbrella of respective zonal railway. **Railway may get the work sanctioned at appropriate level, without prior shortlisting by Railway Board which was conveyed vide letter under Ref (ii).**
5. Zonal Railways are further advised to upload the yard diagram showing the details of works while creating the proposals for sanction on IRPSM.
6. To effectively monitor the progress made in this regard at Board level, railways are requested to send the yard-wise position in the format annexed in next one month and process for sanctioning of itemized works.
