Sub: Uploading of Technical/Key personnel details on the IREPS portal at the time of bid submission of PMS, PSSA, GC etc. which shall be exclusively downloaded from INFRACON portal

Ref: Railway Board letter no. 2024/CE-1/CAO(C)/Workshop (INFRACON) dated 14.06.2024 and 19.09.2024 & MoRTH's letter dated 12-02-2025

1. In reference to the subject mentioned above, it is hereby conveyed that the Ministry of Road Transport and Highways (MoRTH) has granted in-principle approval for the integration of CRIS platforms (IREPS and IRWCMS) with INFRACON portal vide letter dated 12.02.2025.

INFRACON Portal developed by NHIDCL is a comprehensive portal for Infrastructure Consultancy firms & Technical/Key Personnel. The portal has the facility to register Firms & Technical/Key personnel. The Portal also facilitates to upload online CVs and Credentials of Technical/Key personnel with linkage to Aadhaar & Digi-locker for data validation & genuineness along with third-party authentication of educational qualifications and work experience.

Integration of CRIS portal and INFRACON portal is intended to facilitate the selection of verified & qualified Technical/Key personnel for participation in railway tenders (PMS, PSSA, GC, etc. tenders). The process of integration of INFRACON portal with IREPS and IRWCMS is in progress and meetings are going on with NHIDCL. It is expected to take some more time to complete the said integration.

- 2. Meanwhile, as the verification of credentials (Personal details, educational qualifications and work experience) through Aadhar, Digi-Locker linkage and third-party authentication on INFRACON portal may require a certain processing duration, all Zonal Railways including Construction Units and Production Units are requested to actively promote and encourage registration on https://infracon.nic.in of probable Contractors and Technical/Key personnel for PMS, PSSA, GC, etc. tenders to avoid procedural delays.
- 3. Until the integration process is fully implemented, suitable clause in tender documents of PMS, PSSA, GC etc. may be incorporated to manually upload Technical/Key personnel details on the IREPS portal at the time of bid submission which shall be exclusively downloaded from INFRACON portal.
