Shri Amit Sharma, 129/44, "Shivam" Shiv Colony, Naya Ghar, Gulab Bari, Ajmer was served with a memorandum and statement of charges for banning of business dealings with them for malpractices committed by them in execution of the work for "Supply of potable water at Bhagwanpura, Khimel and Biroliya stations by road tankers" by North Western Railway vide Contract Agreement No. W.A.707/2/439-1 dated 03.06.2010 and Contract Agreement No. 01/Track/CKP/12-13 dated 12.04.2012 for costing Rs. 6,66,718.25/-.

- 2. Reply to the Memorandum submitted by Shri Amit Sharma through Shri Vipin Saxena, Advocate has been considered by the competent authority and an opportunity was given to him to present his case in person. Shri Amit Sharma did not turned up for the hearing and therefore, the competent authority has taken decision and concluded that Shri Amit Sharma indulged in malpractices by producing fabricated documents.
- 3. It has, therefore, been decided by Ministry of Railways (Railway Board) to ban business dealings with Shri Amit Sharma, whose address is given below and their allied/sister concerns/partners for a period of **3 (three)** years commencing with immediate effect on Indian Railways and Production Units etc.:
