(five) years.


M/s. Raasi Brisks & Jelly, Contractor, No. 62 D-1, Kamraja Street, Kancheepuram-631501, Tamil Nadu were served with a memorandum and statement of charges for banning of business dealings with them for malpractices committed by them in execution of the work for "CGL-AJJ section - Collection & supply of 50mm size machine crushed stone ballast along side the track including dumping in ADEN/AJJ sub division vide LOA No. M/W.496/West/3669 dated 25.06.02 at a total value of Rs.25,59,600/-(Rupees Twenty Five Lakhs Fifty Nine Thousand Six Hundred Only).

2. No reply to the Memorandum has been received from M/s. Raasi Brisks & Jelly, Contractor, Kancheepuram, Tamil Nadu. The competent authority has taken ex-parte decision and concluded that M/s. Raasi Brisks & Jelly, Contractor, Kancheepuram, Tamil Nadu indulged in malpractice.

3. It has, therefore, been decided by Ministry of Railways (Railway Board) to ban business dealings with M/s. Raasi Brisks & Jelly, Contractor, Kancheepuram, Tamil Nadu whose address is given below and their allied/sister concerns/partners for a period of 05 (five) years commencing with immediate effect on Indian Railways and Production Units etc. :
