

CRS inspection of newly gauge converted BG section between Narpatganj (NPV) and Forbesganj (FBG) was conducted on 11-01-2023 and CRS has authorized public carriage of passenger traffic at MPS of 100 kmph.

The distance between Lalitgram (LLP) and Forbesganj is 28.74 km and extending existing trains will provide connectivity to Forbesganj with other places in Bihar, like Saharsa and Darbhanga.

Accordingly, ECR has proposed for:

- i) Extension of 05516/15 Saharsa-Lalitgram Special up to Forbesganj AND
- ii) Extension of 05579/80 Darbhanga-Jhanjharpur Special upto Forbesganj with timings as mentioned in the table above in Note#45.

The trains will have stoppages at all en route stations on the extended portion.

In view of the above, ECRs proposal of extension of above two trains upto Forbesganj may kindly be approved please.
