सं. 2018/ई एंड आर/1(3)/11.—सर्वसाधारण के सूचनार्थ एतद्वारा अधिसूचित किया जाता है कि परिचालनिक आवश्यकताओं को ध्यान में रखते हुए, केंद्र सरकार ने उत्तर मध्य रेलवे के झांसी मंडल और आगरा मंडल के क्षेत्राधिकार को संशोधित करने का विनिश्चय किया है।

उदीमोर जं. स्टेशन (उदीमोर जं. से इटावा होम सिगनल तक 12 कि.मी. रेलपथ सहित) का क्षेत्राधिकार कि.मी. 1329/4-5 से 1341/5 तक उत्तर मध्य रेलवे के झांसी मंडल से आगरा मंडल में ट्रांसफर किया गया है। उत्तर मध्य रेलवे के झांसी मंडल और आगरा मंडल के बीच नई बाउंड्री इटावा-भिंड लाइन पर 1329/5 कि.मी. पर होगी।

उक्त क्षेत्राधिकार में परिवर्तन 15 अक्टूबर, 2018 से प्रभावी होंगे।

No. 2018/E&R/1(3)/11.—It is hereby notified for general information that keeping in view the operational requirements, Central Government has decided to revise the jurisdiction of Jhansi Division and Agra Division of North Central Railway.

The jurisdiction of Udimor Jn (including 12 Km track from Udimor Jn to Etawah Home Signal) from KM 1329/4-5 to 1341/5 station is transferred from Jhansi division to Agra division of North Central Railway. The new boundary between Jhansi Division and Agra Division of North Central Railway will be 1329/5 km on Etawah-Bhind Line.

The changes in the above jurisdiction will come into effect from 15th October, 2018.
