सं. 2020/ई एंड आर/1(3)/12.—सर्व साधारण के सूचनार्थ एतद्दवारा अधिसूचित किया जाता है कि परिचालिन आवश्यकताओं को ध्यान में रखते हुए, केंद्र सरकार ने पूर्व तट रेलवे के संबलपुर मंडल और खुरदा रोड मंडल के क्षेत्राधिकार को परिवर्तित करने का विनिश्चय किया है। यह क्षेत्राधिकार अब जरापदा और केरेजंगा के बीच कि.मी. 140.400 पर निर्धारित किया गया है, परिणामस्वरूप संबलपुर की ओर 13.600 कि.मी. शिफ्ट हो गया है।

क्षेत्राधिकार में उक्त परिवर्तन होने से, केरेजंगा स्टेशन, संबलपुर मंडल से खुरदा रोड मंडल में स्थानांतरित हो जाएगा और अंतर-मंडलीय इंटरचेंज पाइंट भी अंगुल से केरेजंगा शिफ्ट हो जाएगा।

उक्त क्षेत्राधिकार में परिवर्तन 15 जनवरी से लागू होंगे।

#### **NOTIFICATION**

No.2020/E&R/1(3)/12.—It is hereby notified for general information that keeping in view the operational requirements, Central Government has decided to change the jurisdiction of Sambalpur(SBP) and Khurda Road (KUR) Divisions of East Coast Railway. The jurisdiction is now fixed at Km. 140.400 between Jarapada and Kerejanga, resulting in a shift of 13.600 Kms towards Sambalpur.

With above jurisdictional change, Kerejanga station will be transferred to KUR Division from SBP Division and also shift the inter-divisional interchange point from Angul to Kerejanga.

The changes in the above jurisdiction will come into effect from 15<sup>th</sup> January 2021.
