F. No. 2021/E&R/1(3)/8.—It is hereby notified for general information that keeping in view the operational requirements. Central Government has decided to revise the jurisdiction of Bhopal Division of West Central Railway and Nagpur Division of Central Railway.

The jurisdiction of Bhopal Division of West Central Railway has been extended beyond existing 750,000 Km upto 751,100 km towards Itarasi- Nagpur Line. The new boundary between Bhopal Division of West Central Railway and Nagpur Division of Central Railway will now be 751,100 km on Itarasi-Nagpur section.

The above change will come into force with immediate effect.
