TERMS OF REFERENCE

The study has been conducted under the following terms of references:

- a) To review of staff vis-à-vis workload of control of Operating department of Sonpur Division with a view to identify the surplus manpower in this unit.
- b) To assess the effective utilization of staff working in control of operating department of Sonpur
- c) To suggest for optimization of wages of operating control staff.

METHODOLOGY ADOPTED

The team applied the following work study techniques for conducting the study.

- 1- Data collection and its analysis to assess the factual status & existing work load.
- 2- Spot observations and physical checks to assess the performance of operating staff in control sonpur.
- 3- Discussion with Sr.DOM/SEE
- 4- Discussion with all concerning in charge of section.
- 5- Discussions at various levels of staff to arrive at fruitful result.
- 6- Reassessment of manpower requirement by applying need base.

SYNOPSIS

Indian Railway is one of the biggest transportation organizations among all other transport organizations in the country. In fact, Railway is backbone of the country's transport systems. In the recent time, Railway is facing tremendous competition from road and air. At the time of competition transport system should not only the agile, prompt and amenable but also financially viable. In order to bring economy in expenditure the optimum utilization of man, machine and material will have to be ensured.

In Railways, the process of absorption of modernization has been started and still in progress in every sphere of the system. As a result of which certain activities have become fully redundant/ obsolete from existing system. These technological up gradations have shown considerable improvement in the efficiency and manpower productivity in Railways. Keeping in view, all these constraints, Work Study Cell is assigned to conduct work study of medically de categorized staff and deployment of non running/ safety staff for running duty in control of SEE Division with a view to assess the staff requirement as per the existing workload.

To arrive at the actual requirement of staff, the team held discussions at various levels and kept practicability in view.

Chapter-I

1.0 INTRODUCTION

- 1.1 Railway is one of the biggest transport organizations whose services are utilized by a large number of floating populations. It becomes more important to maintain smooth operation of trains .
- 1.2 Control harnesses the efforts of all the departments of Railway and optimizes usage of operational assets viz. track, signals fixed installations and rolling stock.
- 1.3 Main motto of Railway is safety, security & punctuality. Particularly, this work study has been conducted to review the staff strength of medically de categorised staff and deployment of non running duty in control of SEE Division.
- 1.4 All efforts should be made to ensure that revenue is spent carefully over assets, infrastructure and manpower. In other words, Railway administration should curtail wasteful expenditure in operational and maintenance cost so as to bring down the operating ratio, which is the prime indicator of Railway finances.
- 1.5 Benchmarking is a continuous process of comparing different units and identifying which one is the best in the business and then learning how this excellence was achieved and setting out to improve the efficiency of those units, which were behind. If this concept is implemented it will result large reduction in the cost and make significant contribution in improving the efficiency of various unit of the Railways, but East central Railway, Hajipur zone has not infrastructure developed than other zone of Indian railway. Yard stick

of control is not available Work study team observed that assessment of man power on need base is best option.

Chapter-II

PRESENT SCENARIO:-

Function of control office:-

The main function of the Control Office is planning, execution and review with all the three activities going on simultaneously. ii) Planning is aimed at forecasting and optimizing the following:- 1. Interchange 2. Trains to be run section-wise 3. Supply of rakes/ for bulk loading, 4. Release of inward loaded rakes placed for Unloading Information regarding the following items is generally required for this purpose: (a) Analysis of divisional wagon holding (b) Power availability (c) Availability of loads (d) Disposal of empty rakes (e) Demands for loading The plan is made by Control in the early hours of morning and reviewed by Operating Officers. Changes in the plan, as deemed necessary are made at various stages on the basis of updated information received from the activity centers, adjacent divisions and instructions received from the Head Quarters. iii) Execution: The goods operation plan is executed on the basis of actual materialization. of the forecast with suitable adjustments made for short falls /excesses. Yards, Loco Sheds, Stations, Terminals, Lobbies and TXR depots are actively involved in execution of the plan. iv) Review: The trend of the day's position is reviewed by the Chief Controllers and Officers in the afternoon. Detailed review of the previous day's performance is carried out early in the morning by the Operating Officers with the following objectives: 1. Analyzing shortfalls of previous day to take remedial measures and pin-point weak spots. 2. Provide data for planning for the current day. The main features of performance, which can be reviewed, include: • Interchange failures • Divisional Wagon Balance (Wagons on Division) • Train Running • Disposition of empties • Loading at important terminals — and in case of shortfall, reason for the same. • Review of unusual occurrences • Examination of Control Charts • Particulars of stabled loads • Yard performance • Unloading on Division • Registrations and Loading • Power position, utilization of Locos & Terminal detention • Sick line working • Special type of stock • Clearance of piecemeal wagons (sick or otherwise) from roadside stations

Medically de categorized staff should be utilized against vacancy of control staff and fit suitable staff may be utilized for normal running train operation.

Unit/poinst of operating control:- Train operation of Sonpur division are monitor/controlled by section controller .The entire division are divided in four control board namely.

- (i) Katihar Board
- (ii) KTI Board
- (iii) CPI Board
- (iv) SPP Board.

Two additional control are also working such as

- (i) Chief control coaching
- (ii) Chief control Goods.

COIS & FOIS and stock are also working in control office.

CHAPTER - III

CRITICAL EXAMINATION:-

3.1 The actual staff strength of operating control of SEE Division is 45 against the sanctioned strength of 59. Other department has not specific BOS of control. The staff requirement for the present work load at control of SEE Division are arrived at based on the need base.

As per observation work study team found that 55 control staff are required for present work load in control of Sonpur Division. Hence, work study team observed that 04 posts of TNC(02 posts of level -4 , GP- 2400 & 02 posts of level -2 , GP- 1900) may be recommended for surrender and financial saving will be Rs 34.37 Lac per annum. The work is going on without any hindrance

OBSERVATION

During course of work study the data, made available to work study teem by the divisional authority were scrutinized analyzed and it was found that so many employs are be adjusted in clerical cadre were as they can be utilized in some other singular nature of work like control office were no direct operational involvement the basic nature of working of control office other than operating control is transmission of masses which can done by ministerial staff also. It was also observed that no specific cadre exists of other department except operating department .

CHAPTER -IV

Recommendation

Recommendation:-I

On the basis of above analysis it was found that adjustment of medically decategorized staff needs to be reorganized/re-planned. One side division is facing shortage of running staff and due to the same trains are being delayed and on another side, running staff are being unitized in control office which adversely affecting smooth running of trains in division. It is therefore recommended to withdraw the running staff presently working in control, likewise, guard, LP, PWI etc. and in place of them de-categorized running/safety staff may be utilized. It may also enhance productivity and smooth functioning/running of trains in divisions without any sort of financial burden.

Recommendation:-I As per observation Total sanctioned strength of operating control is 59, men on roll is 45 vacancy =14. Work study team observed that sanctioned post of controller is required and 15 TNC is sufficient against sanctioned strength 19. Hence 04 posts of TNC may be recommended for surrender.

Recommendation :- III All concerning department as Commercial ,Electrical Mechanical ,and S&T has no specific BOS of Control except Operating department. Work study team has advised above concerning department may be prepared specific BOS.
