EXECUTIVE SUMMARY

This study was allotted to Central Planning Cell, HQ Office to identify redundant/unproductive activities and to suggest improved methods of working, outsourcing of certain activities in the Running Rooms of Ambala Division under the control of Mechanical (O&F) Department.



SYNOPSIS

Indian Railways is a unique example of unity in diversity in which more than ten departments are working towards achieving single goal of carrying freight and passenger trains at the optimum level of safety, security, reliability and punctuality. To cope with the increasing volume of traffic, it has become imperative to adopt improved working techniques to enhance the efficiency and economy. With the introduction of advanced technology, the working pattern has also been changed and some activities have become redundant. The elimination of such redundant activities has improved the system.

Running Rooms play a vital role for providing adequate and comfortable rest to loco pilots, guards and other running staff to enable them to get refreshed so as to work trains smoothly and efficiently. Most of the running rooms controlled by Mechanical O&F Department over Ambala division have been outsourced, while few others running departmentally.

Keeping in view of above, SDGM/NR directed Central Planning Cell HQ to conduct a review of Running Rooms staff controlled by Mechanical (O&F) Department over Ambala division with a view to optimize the manpower due to advancements/modernization. The work study team suggested certain improved methods in working to increase the man power productivity. The team also kept in view the local working conditions/outsourcing and held discussions at various levels while assessing the requirement of manpower.

Finally, the team is of the opinion that if the recommendations made in the report are accepted and implemented in toto, a net recurring saving to the tune of 249.60 lakh per annum is likely to be achieved after surrendering of 45 posts identified as surplus.

1.0 INTRODUCTION:

- 1.1 Ambala division is an important division of Northern Railway spread over Punjab, Haryana, Rajasthan, Uttar Pradesh & Himachal Pradesh and deals with freight and coaching traffic.
- 1.2 The movement of coaching and freight traffic is controlled by the operating department and employees of different departments contribute directly/indirectly in the train operation. The running room staff is involved indirectly in train operations by extending rest facilities to the loco pilots, quards and other running staff.
- 1.3 As a matter of fact, time bound train operation is essential to bring efficiency in the working system. Loco pilots and guards can work in train operations smoothly only if they have comfortable rest in running rooms. So adequate facilities like provision of AC, RO drinking water, Open Gym etc; have been provided in running rooms.
- 1.4 Most of the running rooms controlled by Mechanical (O&F) Department over Ambala division have been outsourced, while few others are running departmentally. It is seen that outsourced running rooms are more economical than the departmental running rooms.
- 1.5 Keeping in view of above, SDGM/NR directed to conduct the "Review of running rooms staff working under control of Mechanical O&F Department over Ambala Division" to eliminate wasteful expenditure and to optimize utilization of assets and manpower. It was also emphasized that unproductive/obsolete activities to be eliminated to increase manpower productivity.

1.5 TERMS OF REFERENCE

The work study has been conducted under the following terms of reference: -

- i) To review staff strength vis-à-vis workload.
- ii) To suggest ways and means to identify redundant/unproductive activities to eliminate wasteful expenditure.
- iii) To suggest ways and means to improve the system economically in view of modernization and systems development.

1.6 METHODOLOGY ADOPTED

The following method study and work measurement techniques were adopted to conduct the study: -

- i) Data collection and its critical analysis.
- ii) Work sampling, analytical estimation, spot observations, physical checks and yardstick in vogue, if any, to assess the requirement of staff.
- iii) Held discussions at various levels.

- 2.0.0 BRIEF DESCRIPTION, STAFF POSITION, WORKLOAD, CRITICAL ANALYSIS, REQUIREMENT OF STAFF, RECOMMENDATIONS & OBSERVATIONS
- 2.1.0 The train loco pilots and guards are booked to work mail/Express/passenger/goods train and DMU trains as per their link and supervised by Crew Controllers. To provide comfort to the incoming loco pilots/guards, the running rooms facilities are provide at running rooms which are under the control of Mechanical O&F Department over Ambala Division.
- 2.1.1 The study is confined to review the staff working in running rooms under the control of Mechanical O&F Department over UMB Division.

2.2.0 STAFF POSITION

2.2.1 During the course of study, the team collected the category and grade wise staff position of all running rooms from the divisional headquarter, which is annexed as annexure no. II in the report and the summarized position of the same is given as under.

The above table reveals as under:

The on roll staff strength of running room under Mechanical (O&F) Deptt is 62 against the sanction strength of 64 and 02 posts are lying vacant.

2.3.0 CRITICAL ANAYSIS

During the course of study, the work study team collected the data of running room staff working under Mechanical O&F Department from the divisional headquarter and examined critically. It has been observed as under:

- i) It has been observed the running rooms on contract basis are functioning efficiently than that of managed by departmental staff.
- ii) Running room of SRE and BTI is outsourced for housekeeping activities only and the catering is being done by departmental staff.
- iii) The cleaning standard being maintained by contractual labour is satisfactory as well as the contractual cleaning activities are cheaper than the departmental staff
- iv) The running rooms of SRE, BTI, UMB, NLDM, DUI, SML, RPAR and CDG are already running satisfactorily on contract basis @ Rs. ■14225547/-Per annum.
- v) It is proposed to explore the possibility of outsourcing of the running rooms which are functioning departmentally to increase the productivity of Railways.
- vi) After surrendering of 45 running room staff as recommended than 249.60 lakh per annum recurring saving will be achieved.

The above table reveals that the premises cleaning of running rooms, loco lobby, provision of subsidized meals to running staff and washing of linen is being carried out on contract basis successfully @ 14225547/- per annum.

2.4.1 REQUIREMENT OF STAFF IN THE RUNNING ROOMS UNDER MECHANICAL (O&F) DEPARTMENT:

During the conduct of study the work study team observed that running rooms managed by mechanical (O&F) department at SRE, BTI, UMB, NLDM, DUI, SML, RPAR and CDG are functioning successfully on contract basis whereas SRE & BTI are being carried out partially departmentally and partially on contract basis. The kitchen activities are being carried out departmentally whereas housekeeping is managed on contract basis.

The work study team collected the data from divisional headquarter/UMB and examined carefully. The work study team has taken into considerations, the deployment of staff, held discussion at various levels, outsourcing of activities and yard stick in vogue if any while proposing the requirement of staff. The running room wise proposed requirement of staff is given as under.

2.4.2 RUNNING ROOM SAHARANPUR CANTT:

This running room is supervised by the Sr. Crew Controller (Mechanical). The house keeping, cleaning, and washing of running rooms have been outsourced and kitchen activities are functioning by departmental staff.

The above table reveals that the on roll strength is 13 against the sanctioned strength of 09 and there is a variation of 4 posrs.

Occupancy of running room UMB is about 145 men for which the departmental kitchen staff has been deployed. cleaning of rooms, kitchen, toilets/bathrooms, corridor, road area, circulating area, maintenance of lawn, cleaning of drains, channels and change of linen in RR SRE, is running on contract basis @ Rs 1761338/- per annum.

The proposed requirement of running room staff comes to 09 against the sanctioned strength of 09 and there is no surplus staff.

The above table reveals that the on roll strength is 10 against the sanctioned strength of 10 and no post is lying vacant.

During discussion, the work study team was apprised that there are 58 beds in running room and average occupancy of running room is 66 per day. Existing staff is deployed in 03 shifts.

This running room is supervised by the Chief Loco Inspector. Only Mechanized cleaning of Running Room BTI is outsourced and running successfully @ Rs 1369297/- per annum.

OBSERVATIONS AND PROPOSED REQUIREMENT OF STAFF:

Kitchen activities are running departmentally for which staff has proposed as follow:

The proposed requirement of running room staff comes to 10 against the sanctioned strength of 10 and there is no surplus staff.

The above table reveals that the on roll strength is 16 against the sanctioned strength of 17 and 01 post is lying vacant.

This running room is supervised by the SSE/Loco/UMB. Out sourcing of Mechanized Cleaning of Running Room and its surrounding area is running successfully Provision of Vegetarian subsidized Meal/food for Running Staff in Running Room; Ambala Cantt is also being carried out on contract basis @ Rs. 1436061/- per annum.

OBSERVATIONS AND PROPOSED REQUIREMENT OF STAFF:

At present on roll staff strength is 16 against the sanctioned strength of 17 and 01 post is lying vacant. Even after outsourcing of all activities in running room, departmental staff is still deployed which is uneconomical on Railway account and must be curtailed. Since all the activities in running room/UMB are going on contract basis, the work study team is of the opinion that 17 sanctioned posts of running room staff is rendered surplus and hence proposed requirement comes to nil. Thus **17** sanctioned posts of running room staff is rendered surplus and recommended for surrender.

2.4.5 RUNNING ROOM Nangal Dam:

The above table reveals that the on roll strength is 07 against the sanctioned strength of 08 and 01 post is lying vacant.

This running room is supervised by the SSE/Loco. The Cleaning, washing & mopping of running room at NLDM is being carried out on contract basis @ Rs 1232372/- per annum. Provision of Vegetarian subsidized Meal/food for Running Staff in Running Room NLDM is also being carried out on contract basis @ Rs. 1699121/- per annum.

OBSERVATIONS AND PROPOSED REQUIREMENT:

During discussion, the work study team was apprised that there are 48 beds in running room and average occupancy of running room is 46 per day. Out of Existing sanctioned 08 staff 07 men are deployed in 03 shifts.

Even after outsourcing of all activities in running room, departmental staff is still deployed on various activities which is uneconomical on Railway account and must be curtailed. Since all the activities in running room/NLDM are going on contract basis, the work study team is of the opinion that 08 sanctioned posts of running room staff is rendered surplus and hence proposed requirement comes to nil. Thus **08** sanctioned posts of running room staff is rendered surplus and recommended for surrender.

2.4.6 RUNNING ROOM Dhuri (DUI):

The above table reveals that the on roll strength is 09 against the sanctioned strength of 10 and 01 post is lying vacant.

The running room is supervised by the SSE/Loco/DUI. Cleaning Washing, mopping of R/Room, is being carried out on contract basis @ Rs 2437556/- per annum. Provision of subsidized Meal/food for Running Staff in Running Room, DUI is provided on contract basis @ Rs. 651023/-per annum.

OBSERVATIONS AND PROPOSED REQUIREMENT OF STAFF:

During discussion, the work study team was apprised that there are 47 beds in running room and average occupancy of running room is 73 per day. Out of Existing 10 staff 09 men are still deployed in 03 shifts at running room DUI even after outsourcing of kitchen and cleaning activities..

Even after outsourcing of all activities in running room, departmental staff is still deployed on various activities which is uneconomical on Railway account and must be curtailed. Since all the activities in running room/DUI are going on contract basis, the work study team is of the opinion that 10 sanctioned posts of running room staff is rendered surplus and hence proposed requirement comes to nil. Thus **10** sanctioned posts of running room staff is rendered surplus and recommended for surrender.

2.4.7 RUNNING ROOM Shimla (SML):

The above table reveals that the on roll strength is 03 against the sanctioned strength of 04 and 01 post is lying vacant.

During discussion, the work study team was apprised that there are 33 beds in running room and average occupancy of running room is 19 per day. Out of Existing 04 staff 03 men are still deployed in 03 shifts even after outsourcing of kitchen and cleaning activities..

Even after outsourcing of all activities in running room, departmental staff is still deployed on various activities which is uneconomical on Railway account and must be curtailed. Since all the activities in running room/SML are going on contract basis, the work study team is of the opinion that 04 sanctioned posts of running room staff is rendered surplus and hence proposed requirement comes to nil. Thus **04** sanctioned posts of running room staff is rendered surplus and recommended for surrender.

During discussion, the work study team was apprised that there are 28 beds in running room and average occupancy of running room is 07 per day. Out of Existing sanctioned 06 staff 04 men are still deployed in 03 shifts even after outsourcing of kitchen and cleaning activities..

Even after outsourcing of all activities in running room, departmental staff is still deployed on various activities which is uneconomical on Railway account and must be curtailed. Since all the activities in running room/RPAR are going on contract basis, the work study team is of the opinion that 06 sanctioned posts of running room staff is rendered surplus and hence proposed requirement comes to nil. Thus **06** sanctioned posts of running room staff is rendered surplus and recommended for surrender.

2.4.11 The summarized position of existing sanctioned strength, proposed staff and surplus posts of running room staff working under Mech (O&F) over FZR division is given as under:

2.5.0 GENERAL OBSERVATIONS:

During the conduct of study the work study analysed the working of running room staff working under Mechanical (O&F) Department. It has been observed that the contractual work is found more economical and satisfactory than the departmental staff. AT Present housekeeping & kitchen activities of running rooms at UMB, NLDM, DUI, SML RPAR are functioning on contract basis successfully. Whereas housekeeping activities (Mechanized cleaning) at running rooms SRE & BTI are being carried out on contract basis and kitchen activities are being carried out departmentally. The work study team is of the opinion that the possibilities may be explored to outsource the kitchen activities at SRE and BTI and after outsourcing resultant posts of running rooms staff will be rendered surplus.

Recommendation 2:

It is proposed to explore the possibility of outsourcing of the running rooms which are functioning departmentally to economise the system.
