CHAPTER -IV

CRITICAL ANALYSIS AND STAFF REQUIREMENTS

A. SSE/Works/BNGN

1. SSE/Works/BNGN:- The Work Study Team critically examined the various activities & work load of according to the activity-wise observation it is seen that work load is in decreasing trend. The reason is that numbers of activities are either off loaded or some activities are becoming obsolete. More over now-a-days maximum works are done by the Railway through contractual basis where mere supervision lies on the part of SSE/Works.

1.1 Requirement of allied staff:

Painter:-The activities of Painter are not a routine work & reduced immensely for off loading of some activities. Keeping in view the above facts the study team considered the following staffs which are adequate to meet the requirement. Painter = 01.Against category of Painter there are 2 nos sanctioned posts against onroll 1 nos staff, hence work study team suggests the vacant 1 nos post to surrender, since the works of painting are presently being executed by outsourcing.

1.2 Requirement of S. W. Man:

There are 5 (Five) Nos. of Go down are to manned by 2 nos S. W. Man under SSE/WORKS/BNGN, So 2 nos SWM are required in that unit.

1.3 Requirement of FPO & FPO Helper:

Considering the work load 10 Nos. of FPO & FPO Helper together as per BOS against on roll 2 nos FPOs only . Presently the category of FPOs & FPO khalasis are managed mostly by out sourcing however keeping in view of unforeseen work load in near future, to meet the requirement the work study team suggests to surrender 2 posts from Khalasi(FPO) & 1 post each from FPO , Gr-I , II & III each

1.4 Requirement of Carpenter/Mason/Fitter:

- a) Carpenter: The replacement of doors of all the Quarters either by PVC or Iron, had reduced the workload of Carpenter drastically, so the team suggests 06 Nos. of Carpenter to meet the requirement which includes the BOS of 1 no Sr.Tech Carpenter. Therefore it is understood that 4 post from carpenter Gr-I category may be deleted from the BOS against 10 nos sanctioned posts and keep the promotional avenue intact.
- b) Mason: Against this categories 04 Nos. posts are sanctioned including 1 nos post of Sr. Tech. Mason (MCM). Vise 2 nos on roll staff. Presently masonry works are mostly dealt by out sourcing thus drastically reduced the necessity of Mason under SSE/W's units. Apprehending this 1 posts may be surrendered from BOS keeping the rest one vacant posts intact with the apprehension of future unforeseen increased workload.

c) **S/Mason**: Considering the workload 01 Nos. of S/Mason are adequate to meet the requirement. The vacant post of S/Mason, Gr.-III may be surrendered from BOS

d)Fitter: Against this category 05 Nos. posts are found sanctioned. Vise 2 no on roll staff. Leaving 3 nos vacant posts since long. Since the said unit is running smoothly/uninterrupted for long period with 3 nos vacant posts therefore 2 posts from Fitter Gr.-I post may be surrendered to achieve financial viability leaving 1 nos posts intact for any future requirement.

e)Requirement of Helper: There are 5 Nos. sanctioned posts against Khalasi Helper. Since the said unit is running smoothly/uninterrupted for long period with 2 nos vacant posts therefore 1 posts from this category may surrendered to achieve financial viability leaving 1 nos posts intact for any future requirement.

B. <u>SSE/Works/DTX</u>:- This is a very small unit having only a sanctioned strength of together 13 staff against on roll staff of 7 nos. However there are together 4 nos sanctioned strength of Khalasi/helper vice onroll strength of 1 only and the vacancy against these category persists since long. therefore work-study team suggests 2 posts to surrender from this unit against this category.
