1.0 **INTRODUCTION**

Education in India is provided by both public and private sector which falls under the control of both Central and State governments. Under Indian constitution education is a fundamental right. In the year 2009, India enacted an Act in the parliament which describes the importance of free education between 6 and 14 years of age and the Act came into force from 1st April 2010, named as RTE Act 2009 (Right of Children to Free and Compulsory Education Act). The Act provides that no child shall be held back, expelled or required to pass a Board examination until the completion of elementary education. There is also a provision for special training of school drop-outs to bring them up to par with the students of the same age.

1.1 Today education system in India is categorized as follows

Pre primary School	3 to 5	LKG & UKG
Primary School	6 to 11	1 st to 5 th Std
Middle School	12 to 14	6 th to 8 th Std
High School	15 to 16	9 th & 10 th Std

In India, education is compulsory until the age of 14. High school is a grade of education upto X and higher secondary school or Junior college will be upto class XII. The schools are affiliated to either National boards like CBSE, ICSE or various state boards.

1.2 Many Government Departments like Railways, Defence, Production units and Public Sector Units also run a sizeable number of educational institutions without any assistance from Central / State Governments. Indian Railways run nearly 200 schools. They impart education not only to the wards of the employees but also to the wards of people around the area.

1.3 The policy regarding Railway schools as given in the Indian Railway Establishment Manual, Part II, and Chapter XXII is given below.

Chapter-XXII

Staff Welfare

Section A

Schooling faculties and educational assistance for the children of Railway servants

- **2201. Policy regarding Railway Schools** .- Education being the concern of State Governments, the policy of the Railway Ministry is not to enter the field except to the limited extent indicated below:
- (a) Provision of facilities in railway colonies to the extent that the State Governments or other educational organizations are not willing to provide them. Elementary education and, where no high schools are available in the neighborhood, education upto the High school should be deemed as an inescapable responsibility in railway colonies, if the only alternative is to let the children of railway workers are without any educational facilities.
- (b) Where railway servants are posted in out of the way places, some provision should be made for getting their children educated in High Schools and colleges.

There are 9 Railway schools in Southern Railway, at PER, AJJ, JTJ, VM, GOC, MDU, ED, PTJ and PGT (All English Mediums).

The study pertains to the Railway Mixed High school located at Villuppuram

3.0 **CRITICAL ANALYSIS**

3.1 **General**

The policy regarding Railway schools as given in the Indian Railway Establishment Manual, Part II, and Chapter XXII is given below.

Chapter-XXII Staff Welfare Section A

Schooling faculties and educational assistance for the children of Railway servants

<u>2201.</u> **Policy regarding Railway Schools .-** Education being the concern of State Governments, the policy of the Railway Ministry is not to enter the field except to the limited extent indicated below:

- (a) Provision of facilities in railway colonies to the extent that the State Governments or other educational organizations are not willing to provide them. Elementary education and, where no high schools are available in the neighborhood, education upto the High school should be deemed as an inescapable responsibility in railway colonies, if the only alternative is to let the children of railway workers be without any educational facilities.
- (b) Where railway servants are posted in out of the way places, some provision should be made for getting their children educated in High Schools and colleges.

The transportation facilities have also improved manifold. However for easy admission of the wards of employees who have to undergo periodical transfers, the Railway schools as well SRWWO controlled schools are of great help. The issue of educational facilities at low cost or free is solved to a great extent due to the enhancement of tuition fee reimbursements at reasonable levels.

Education being a concurrent subject of State and Central Governments., the administrative control of schools by Railways is to be viewed in a holistic manner. Many of the facilities allowed to students by States/Central govt., controlled schools are denied to Railway schools even though wards of non-Railwaymen are also studying in the school..

The trend of students' strength and also the Classes conducted was drastically decreasing for the past consecutive years, in the year 2015-16 the total students were 163 and the class conducted from III to X. but for the current year 2019-20 the total students were only 44 and the class conducted from VII to X. (ie., the reduction of 73.01% in the 5 years period)

3.4 Tamil Nadu School Education Department accept the Central Govt Act 35 of 2009 "The right of children to free and compulsory education Act 2009" (RTE 2009) for their State policy through G.O. MS No.173/school education(CL) dated 8th November 2011. RTE Act 2009- stipulates Norms and Standards for the schools in "The Gazette of Indian extraordinary-Part II", which is the guideline for the Teacher pupil ratio. This Yard stick is applied for this study, to assess the teaching staff requirement.

 - The PT Teacher is in Teacher Gr.II
 - Teacher Gr.IV are handling Classes I to V.
 - Teacher Gr.II are handling classes VI to X.
 - HM post is accounted in the strength of Teacher Gr. II
 - There are no RTE norms for standards IX & X.
- 3.7 The present staff strength for Std. VII to X is 44 The norms given in RTE 2009 is from 1stStd to 8th Std only. Hence, the norm prescribed for VI to VIII Std is applied for IX and X Standards also.

The total arithmetical requirement is **One Head Teachers, Two Teachers, One Physical Training instructor and Two part time teachers for Art and Work education**. Even if allowed, 2 part time teachers as regular faculty the **total requirement are Five only**.

The sanctioned teaching staff strength is 11 and the actual is 5, as per the above norms, the sanction strength is in excess of 6 to the requirement.

The Teacher requirement as per the norms for the average strength:

The norms denoted that at least one class-room for every teacher has to be provided. The present No. of classes in RMHS/VM is only 4

No. of periods for the 4 classes in a week $= 4 \times 8 \times 5$

= 160 periods

As per the norms, the maximum number of working hours per week for a teacher is 45 (including preparation hours). In practice 45 periods per Teacher per week will not fit for the present situation, because lot of special care to be taken to the Primary kids also extra/special classes are regularly being conducted for IX and X students.

The facts are considered and the work study team identified that a teacher can attend maximum of 6 periods in a day for teaching and the remaining 2 periods to be utilized for preparation and correction activities.

Based on 6 periods in a day, a teacher can handle 30 periods of classes in a week.

Total number of periods in a week = 160

Total number of teachers required = 160/30

= 5.33

a. Teachers (Incl. language) = 5.33

b. Allowing 1 more for Reserve = 1

All other ministerial and supporting staffs are identified on the need basis.
