CHAPTER: - I

INTRODUCTION

CHPTER - II

2.0.0 Present scenario:-

1.1.0 The actual staff strength of Waiting Room Bearer of Commercial Department of Samastipur Division is 22 as against the sanction strength of 27 (Reference-Annexure — I as per gradation list of commercial department for the month of December 2020.

2.1.0 THE REQUIREMENT OF STAFF AT DIFFERENT POINTS AND LOCATIONS

Waiting Room Bearer of Commercial Department is working under the control of CIT to arrive at a factual conclusion on requirement of staff of SPJ division. The work study team collected the workload of all activities. For calculation of manpower required, the team applied on spot observations and discussions at various levels.

CRITICAL EXAMINATION

3.1.0 The actual staff strength of W.R.B of commercial department/SPJ is 22 as against the sanctioned strength of 27 with a vacancy of 05 posts the staff requirement for the present workload at commercial department SPJ are arrived at based on the need base.

BOS = 27

MOR = 22

Vacancy =05

Requirement as per work study team =13

Staff excess =27-13=14

3.4 Staff surrender on the basis of need base.

The Work study team observed that 13 W.R.B are sufficient for present work load of Waiting Room, Retiring Room and Dormitory of Commercial Department of Samastipur Division. Hence, 14 post of W.R.B may be surrendered.

CHAPTER - IV

RECOMMENDATION:

The main duty of WRB of Commercial Department is to attend Waiting Room, Retiring Room and Dormitory etc.

There are 22 men on roll against the sanctioned strength of 27 in SPJ Division. The 14 posts of WRB of Samastipur division are recommended for surrender.

Total Sanction Strength = 27

Total Men on Roll = 22

Total Staff required = 13

Excess Staff =27-13 = 14 Staff

After going through the requirement of staff, the work study team observed that the 14 posts of WRB of Commercial Department, recommended for surrender and financial saving will be Rs 73.61 Lac per annum.
