Sub: - Use of Regional Languages in Departmental/Course end examinations.

One of the zonal railways has sought clarifications on the use of regional languages in various selections/departmental examinations/examinations at the end of training courses etc. Instructions in this regard had been issued vide Board's letters No.E(Trg.)1-70/TRT/122 dated 8.12.1970, 3.6.1971 and No.E(NG)1/90/PM-1/41 dated 8.7.1992.

It is clarified that the instructions contained in above mentioned letters dated 8.12.1970 and 3.6.1971 apply to the examinations conducted at end of training courses and those issued vide above mentioned letter dated 8.7.1992 apply to selections/suitability tests conducted for purpose of promotion etc. It is further clarified that in cases of selection/suitability tests for promotion where the knowledge of English is considered essential for the discharge of day to day functions of the relevant category of employees, the same may be separately tested. While so doing, the scope of this testing should be confined only to the actual requirements of understanding instructions/communications etc. as required in normal course of day to day working for the employees of that category.
