Sub: Declaration of "Local Holiday" on 13.11.2024 for bye-polls to State Assembly

of Assam.

Ref: NFR's letter No. E/88/0(C) Pt.VII dated 12.11.2024.

In reference to above referred letter, it is reiterated that Board has already issued instructions vide letter No. E(G)2008/LE1/5 dated 02.02.2009 regarding closing of Central Government offices in connection with election to Lok Sabha, State Assembly, Panchayat, Municipality, Corporation or other Local Bodies by enclosing a DoPT's O. M. dated 10.10.2001. In para (ii) of the said O.M., it is clearly stated that in connection with bye-elections to Lok Sabha/State Assembly, only such of the employees who are bona-fide voters in the relevant constituency should be granted Special Casual leave on the day of polling. Special Casual Leave may also be granted to an employee, who is ordinarily a resident of a constituency and registered as a voter but employed in any Central Government Organization/ Industrial Establishment located outside the constituency having a general/bye-election.

As such, it is clear that there is no provision of closure of Central Govt. offices in connection with bye-election to Lok Sabha/State Assembly.

OFFICE MEMORNDUM

Sub: Closing of Central Government Offices in connection with elections to Lok Sabha / State Assembly /Panchayat / Municipalities / Corporation or other Local Bodies - regarding

In modification of thse instructions contained in this D rtment's O.M.No.12/4/86-JCA dated 9th March, 1 undersigned is directed to say that the following guidelines are prescribed for future for closing of Central Government Offices including industrial establishments in connection with the elections indicated above.

- (i) The relevant organizations shall remain closed in the notified areas where general elections to Lok Sabha or State Legislative Assembly are scheduled to be conducted.
- (ii) In connection with bye-election to Lok Sabha / State Assembly, only such of the employees who are bona-fide voters in the relevant constituency should be granted special casual leave on the day of polling. Special Casual leave may also be granted to an employee who is ordinarily a resident of a constituency and registered as a voter but employed in any Central Government Organization / Industrial Establishment located outside the constituency having a general / bye-election.
- (iii) In connection with local body elections, viz., Panchayat/ Corporation / Municipality, the Government employees who are bonafide voters and desire to exercise their franchise should be offered reasonable facility, subject to normal exigencies of services, either by coming late to office or being allowed to leave office early or a short absence on that day.



The employees detailed on election duty may also be permitted to remain away from their normal duties on polling day (s) as also on the days required for performing journeys which might be undertaken in order to perform such election duty.

The above instructions may be brought to the notice of all

Please refer to the letters quoted above (copy enclosed), as per which the local Administration/State Government have declared "Local Holiday" in certain parts of Assam for the Assembly bye-polls to be held on 13th November, 2024.

In this respect, it is mentioned that N. F. Railway has been following DoPT's instructions vide Office Memorandum Nos. (1) 12/14/99-JCA dtd. 10th October, 2001 & (2) 12/1/2022-JCA dtd. 5th April, 2024 and Railway Board's letter No. E(G)2008 LE1/5 dtd. 02.02.2009 for enabling bona-fide voters (amongst railway staff) to vote. However, no Railway unit was given complete holiday on this ground.

Since, there is a confusion on account of the letter issued by the Election Officer, Bongaigaon, (under reference No. 2 above addressed to ADEN, N. F. Railway, New Bongaigaon) Railway Board is requested to clarify whether the local Railway units should also declare a local holiday on the day of the bye-polls or will the instructions of DoPT supersede the local orders of the State Government/local administration.

An early reply is requested.
