Sub: Circulation of Provisional Integrated Seniority List of Public Relations Officers (Group 'B') of Public Relations Department of Indian Railways as on 01.01.2024.

On the basis of Group 'B' seniority lists circulated earlier vide Board's letter dated 11.08.2021 and the data available, the Group 'B' seniority of Public Relations Department of Indian Railways has been integrated based on the following principles:

- i) In the order of Group 'B' dates of the officers, but without disturbing the prevailing interse seniority on each Railway Zone/Production Unit.
- ii) For those who have joined the Railways on transfer from other Railways on bottom seniority basis, the dates on which the orders for such transfers are issued by the Railway Board or the actual date on which such officers join the Railways on bottom seniority basis, whichever is later, will be treated as their Group 'B' dates for the purpose of integrating the Group 'B' seniority on All India basis.
- iii) When Group 'B' dates happen to be the same, officers with earlier date of birth will rank senior to those with later date of birth.
- 2. Based on the above mentioned principles, the provisional integrated seniority list of Group 'B' officers of Public Relations Department as on 01.01.2024 (Annexure-I) is enclosed. It may be noted that this list has been prepared for the limited purpose of induction to Group 'A'/Sr. Scale. The same may be circulated immediately calling for representations, if any, within 30 days positively from the date of circulation. UPSC has taken a very serious view with reference to the review DPCs having being necessitated due to incorrect information in the seniority lists, particularly with regard to category, Date of Birth and Group 'B' date. Therefore, contents of columns 2 to 7 may be cross-checked by the concerned Railways thoroughly before they are actually circulated. If any mistake is found later, the onus will lie on the concerned Railways/PUs. If any of the officer(s) in the enclosed List has since ceased to be in service (other than by superannuation), the same may be advised immediately.
- 3. It may also be ensured that any Group B officer, who is not figuring in the enclosed seniority list as on 01.01.2024 (Annexure-I) may be brought to the notice of Board for inclusion of their names in the final seniority list.
- 4. As and when Representation(s) are received, the same may be forwarded to Board's office with comments, clearly indicating whether the contentions raised in the representations are correct as per their official records. Any representations forwarded without comments will not be entertained and the onus will lie on the concerned Railways.

- 5. If no representation(s) are received within the stipulated period, the said list shall be treated as final. In any case, if no reply is received within 45 (forty five) days from the date of issue of this letter, from the Rlys/PUs, it shall be presumed that no such representation(s) have been preferred and the list shall then be treated as final.
- 6. In this regard attention is invited to Board's letter No.E(GP)2022/1/38 dated 25.10.2022 (RBE No. 132/2022) wherein it was decided that provisions for grant of Reservation to PwBDs, as contained in DoP&T's OM dated 17.05.2022, shall be implemented in respect of "Eight" organized Group-'A' Railway Services/Indian Railway Management Services (IRMS) & Miscellaneous Services of Indian Railways, while considering promotions from Group-"B" to Group-"A" posts from the Panel Year 2022 onwards. Accordingly, If any of the officer(s) figuring in the enclosed seniority list as on 01.01.2024 (Annexure-I) belongs to PwBDs, the same may be intimated to this office immediately.
- 7. It may be noted that this integrated seniority list is not exhaustive.
