

Federation demanded that there are four Divisional Councils Meetings conducted. Two of which are held separately, and remaining two in conjunction with PNM. As number of divisional council are large and DC meetings are to be held separately, accordingly, facilities needs to be granted.

43/2015: Provision of rail net/internet connections to the offices of the recognized Unions and provision of CUG SIMs to the Office Bearers at Branch level-reg.

The Federation demanded that branch secretary, president/chairman should also be extended CUG facility.

As per the Board's telecom circular No. 05/2023 dated 12.04.2023 issued by the Board, branch office bearers of the recognised Federations/Unions have been covered for grant of CUG facility. The demand will be examined in light of the telecom circular 05/2023.

60/2016: Holding seminars, conferences and workshops on safety related issues by the recognized Federations and their affiliates – Grant of facilities-reg.

Federation wanted Railway Board to allow facilities for holding safety conference etc., in association with concerned officers for the purpose of enhancing safety consciousness, skill levels and alertness levels.
