Sub: Delegation of powers for allowing retention of Railway accommodation in NF Railway.

Proposal to grant specific or discretionary powers to GM and DRMs of N.F. Railway for retention of quarters has been considered by the Board.

- In exercise of its power to make reasonable relaxations in the public interest for a class/group of employees, in all or any of the existing provisions regarding house allotment/retention, the Board have decided to grant specific or discretionary powers to GM and DRMs of N.F. Railway to enable them to permit higher retention period beyond the normal prescribed in cases of inter-divisional and intra-divisional transfer of NF Railway employees on the ground that there are harsh natural conditions, lack of basic facilities of education & health, disturbed law & order and disparity in educational systems of different states falling in the jurisdiction of the Zone, till further orders. However, while exercising these specific or discretionary powers, the decision of Hon'ble High Court of Delhi in Civil Writ petition no 5057 of 1999 should be kept in view.
