Attention is invited to instructions issued vide this Ministry's letter of even number dt.17/10/2001 stipulating that in case two or more candidates secure equal marks in the aggregate (written test + viva voce + record of service) in 30% LDCEs held for promotion to Group 'B' posts, then their relative merit position for the purpose of their empanelment may be determined on the basis of their relative seniority in the feeder grade (s). Herein, it is clarified that the feeder grade may be construed as the grade in which the said candidates are working on non-fortuitous basis on the cut off date for determining the eligibility for the said LDCE.

आपका ध्यान इस मंत्रालय के दिनांक 17/10/2001 के समसंख्यक पत्र के तहत जारी अनुदेशों की ओर दिलाया जाता है, जिसमें यह अनुबंध है कि ग्रुप 'बी' पदों पर पदोन्नति के लिए आयोजित 30% सीमित विभागीय प्रतिस्पर्धात्मक परीक्षा में यदि दो अथवा दो से अधिक उम्मीदवार कुल मिलाकर (लिखित परीक्षा+मौखिक परीक्षा+सेवा का रिकॉर्ड) समान अंक प्राप्त करते हैं तो उनको पैनल में रखने के प्रयोजन से उनकी संबंधित मेरिट स्थिति का निर्धारण फीडर ग्रेड (ग्रेडों) में उनकी संबंधित वरिष्ठता के आधार पर किया जाए। इसमें यह स्पष्ट किया जाता है कि फीडर ग्रेड को उस ग्रेड के रूप में माना जाए, जिसमें उक्त उम्मीदवार उक्त सीमित विभागीय प्रतिस्पर्धात्मक परीक्षा के लिए पात्रता निर्धारित करने के लिए अंतिम तारीख को गैर-आकस्मिक आधार पर कार्यरत हैं।
