Sub:- Simplification of the work of calculation
of the rates of Night Duty Allowance.

Ref:- Railway Ministry's letter No.PC(3)73/NDA
dated 16.9.1975.

The question of simplification of the work of calculation of the rates of Night Duty Allowance was discussed in the Committee of the Departmental Council (JCM) held on 9.9.1981. In order to avoid any calculation for the revision of Night Duty Allowance rates with the announcement of Additional Dearness Allowance instalments and to expedite the payment of Night Duty Allowance to the staff concerned, the Ministry of Railways have decided that for every additional instalment of the Additional Dearness Allowance sanctioned, the hourly rates of Night Duty Allowance laid down in Board's letter No.P&A/II-80/HW-1 dated 12.11.1981 for "Continuous" "Intensive" "excluded" Class III and workshops staff and also "Essentially Intermittent workers" may be increased by 5 (five) paise in the case of employees drawing pay extending upto Rs. 500/- per month and 10 (ten) paise in the case of those whose pay is above Rs. 500/- per month subject to the existing terms and conditions.

2. The above orders take effect from the dearness allowance instalments sanctioned with effect from 1.6.1981 and for all future instalments sanctioned thereafter.

3. This has the sanction of the President and issues with the concurrence of the Finance Directorate in the Ministry of Railways.
