Sub: Cash payment in lieu of Leave on Average
Pay on the date of retirement - payment
to Running Staff.

In terms of this Ministry's letter No. F(E)III-77/LE1/4 dated 15.11.77, all Railway servants are entitled to the payment of cash equivalent of leave salary in respect of the period of leave on average pay at their credit at the time of retirement on superannuation, subject to the cash equivalent being limited to a maximum of 120 days leave on average pay. It has been further laid down vide para 3(c) *ibid* that the cash payment under the said orders will be equal to the leave salary as admissible for leave on average pay.

2. A doubt has been raised whether in the case of Running Staff, the cash equivalent of leave salary as aforesaid will also include that portion of the Running Allowance which is treated as pay in terms of Rule 744 (B) (2)-R.I. as modified by this Ministry's letter No. PC.III/75/RA/1 dated 22.3.76. It is clarified that in the case of Running Staff, the calculation of leave salary for the aforesaid purpose will be done in the same manner as in the case of leave on average pay while in service, that is to say on the basis of pay plus actual amount of Running Allowance subject to a maximum of 45% of pay.

3. The clarification contained in para 2 above takes effect from 30.9.77.

4. This has the sanction of the President and issues with the concurrence of the Finance Directorate of the Ministry of Railways.




