Sub: Weightage for Night Duty - Revised hourly rates of Night Duty Allowance.

Ref: Railway Ministry's letter No. PC(3) 73/DA dated 16.9.75.

Consequent upon the grant of additional dearness allowance to railway employees in terms of Railway Ministry's letters No. PCIII/76/DA dated 9.10.79, 27.3.80, 18.6.80, 4.8.80 and 4.10.80 W.S. from 1.8.79, 1.11.79, 1.2.80, 1.5.80 and 1.7.80 respectively, the revised rates of Night Duty Allowance with effect from 1.8.79, 1.11.79, 1.2.80, 1.5.80 and 1.7.80 to staff drawing pay in the revised scales of pay are indicated in the enclosed Annexures 'A' and 'B', showing the revised rates of Night Duty Allowance per weighted hour for 'continuous' 'intensive' 'excluded Class III staff' under Hours of Employment Regulation and Workshop staff in respect of various classified cities; and also the revised rates of Night Duty Allowance payable to those classified as 'essentially intermittent' under Hours of Employment Regulations.

2. These rates will also apply to Railway servants who have elected to retain the pre-revised scales of pay. In their case pay for the purpose of determining the rates of pay as indicated in Annexures 'A' and 'B' to this letter will include the basic pay, special pay and personal pay and also Dearness pay, Dearness Allowance and interim reliefs as admissible on the basic pay on 31.12.72. 
instructions contained in this Ministry's letter No.PC(S)73M/1 dated 24.1.80 are relevant.

3. The conditions laid down in paras 4 and 5 of Railway Ministry's letter No.PC(S)73/M/1 dated 16.9.75, referred to above, shall continue to apply.

4. The payment of Night Duty Allowance already drawn by the Railway employees in terms of Railway Ministry's letter No.PC(S)73/M/1 dated 8.8.73 should be revised and arrears due, if any, should be paid to them.

5. This has the sanction of the President and issues with the concurrence of the Finance Directorate of the Ministry of Railways.


