Sub: Revision of pay scales of Railway School teachers and Librarians -on the recommendations of V CPC - clarification regarding fixation of pay.


Ref.: Letters No. PC V/97/RSRP/1, dt. 16.10.1997, S.No. PC-V/2 , PC-V/98/II/11/26 dated 23.10.98, S.No. PC-V/131 and No.PC-V/98/II/11/26 dated 8.1.99, S.No. PC-V/140.

The Ministry of Railways had, on the recommendations of the V CPC, revised the pay structure for the Primary School Teachers, Trained Graduate Teachers, Post Graduate Teachers, Miscellaneous teachers and Librarians of Railway Schools with effect from 1.1.96.

2. With regard to the fixation of pay in the Revised Scales, it is clarified that *"irrespective of the fact whether the revised pay scales are improved or otherwise if the revised pay scale is with the special pay/allowance, in such cases, the amount of special pay/allowance will not be taken into account as part of emoluments for fixation of pay under Rule 7 of RS (RP) Rules, 1997; but, in case the revised pay scales are without special pay/allowance, in such cases amount of special pay/allowance is to be considered as part of emoluments for fixation of pay in the revised scales of pay."*

3. The Ministry of Railways desire early implementation of these orders.



लाइब्रेरियनों के वेतनमान में संशोधन-वेतन निर्धारण के संबंध में स्पष्टीकरण.

सं० पी सी-5/98/आई/11/28 दिनांक 8-1-99, क्रम सं० पी सी-5/140.

पांचवें केंद्रीय वेतन आयोग की सिफारिशों के आधार पर, रेल मंत्रालय ने 1.1.96 से रेलवे
स्कूलों के प्राथमिक स्कूल टीचरों, प्रशिक्षित ग्रेजुएट टीचरों, पोस्ट ग्रेजुएट टीचरों, विविध टीचरों तथा
लाइब्रेरियनों की वेतन संरचना को संशोधित किया था.

2. संशोधित वेतनमानों में वेतन निर्धारित करने के संबंध में, यह स्पष्ट किया जाता है कि "इस
तथ्य पर विचार किए बगैर कि संशोधित वेतनमानों को बेहतर बनाया गया है अथवा नहीं, यदि संशोधित
वेतनमान में विशेष वेतन/भत्ता शामिल रहा है तो इस प्रकार के मामलों में रेल सेवा § संशोधित वेतन §
नियम, 1997 के नियम 7 के अंतर्गत वेतन निर्धारण करने के लिए परिलब्धियों के भाग के रूप में विशेष
वेतन/भत्ते की गणना नहीं की जाएगी, लेकिन यदि संशोधित वेतनमानों में विशेष वेतन/भत्ता शामिल
नहीं रहा है तो संशोधित वेतनमान में वेतन निर्धारण करने के लिए विशेष वेतन/भत्ते को परिलब्धियों के
भाग के रूप में माना जाएगा".

3. रेल मंत्रालय वांछ करता है कि इन आदेशों को शीघ्र कार्यान्वित किया जाए.


